A BILL

To establish an integrated national approach to respond to ongoing and expected effects of extreme weather and climate change by protecting, managing, and conserving the fish, wildlife, and plants of the United States, and to maximize Government efficiency and reduce costs, in cooperation with State, local, and Tribal Governments and other entities, and for other purposes.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Safeguarding Amer-
5	ica's Future and Environment Act" or the "SAFE Act"
6	SEC. 2. FINDINGS, PURPOSES, AND POLICY.
7	(a) FINDINGS.—Congress finds that—
8	(1) healthy, diverse, and productive commu-
9	nities of fish, wildlife, and plants provide significant
10	benefits to the people and economy of the United
11	States, including—
12	(A) abundant clean water supplies;
13	(B) flood and coastal storm protection;
14	(C) clean air;
15	(D) a source of food, fiber, medicines, and
16	pollination of the crops and other plants of the
17	United States;
18	(E) outdoor recreation, which is a source
19	of jobs and economic stimulus;
20	(F) hunting and fishing opportunities and
21	support for subsistence communities;
22	(G) opportunities for scientific research
23	and education;
24	(H) world-class tourism destinations that
25	support local economies: and

1	(I) sequestration and storage of carbon to
2	help mitigate changes to the global climate sys-
3	tem;
4	(2) the United States Geological Survey, Na-
5	tional Oceanic and Atmospheric Administration, Na-
6	tional Aeronautics and Space Administration, and
7	other agencies within the United States Global
8	Change Research Program have observed that the
9	fish, wildlife, and plants of the United States are
10	facing increasing risks from changing patterns of ex-
11	treme weather and climate, including—
12	(A) severe droughts and heatwaves;
13	(B) severe storms and floods;
14	(C) frequent and severe wildfires;
15	(D) more frequent and severe outbreaks of
16	forest pests and invasive species;
17	(E) flooding and erosion of coastal areas
18	due to rising sea levels;
19	(F) melting glaciers and sea ice;
20	(G) thaving permafrost;
21	(H) shifting distributions of fish, wildlife,
22	and plant populations;
23	(I) disruptive shifts in the timing of fish,
24	wildlife, and plant natural history cycles, such
25	as blooming, breeding, and seasonal migrations;

1	(J) increasing ocean temperatures and
2	acidification;
3	(K) altered patterns of rain, snow, runoff,
4	and streamflow; and
5	(L) habitat loss, degradation, fragmenta-
6	tion, and movement; and
7	(3) the Federal Government should provide
8	leadership in preparing for and responding to the ef-
9	fects described in paragraph (2) to ensure that
10	present and future generations continue to receive
11	the benefits of the abundant and diverse fish, wild-
12	life, and plant resources of the United States.
13	(b) Purposes.—The purpose of this Act is to estab-
14	lish an integrated national approach—
15	(1) to respond to ongoing and expected effects
16	of extreme weather and climate change by pro-
17	tecting, managing, and conserving the fish, wildlife,
18	and plants of the United States; and
19	(2) to maximize Government efficiency and re-
20	duce costs, in cooperation with State, local, and
21	Tribal Governments and other entities.
22	(c) National Fish, Wildlife, and Plants Cli-
23	MATE CHANGE ADAPTATION POLICY.—It is the policy of
24	the Federal Government, in cooperation with State and
25	local governments. Indian Tribes, and other interested

stakeholders to evaluate and reduce the increased risks and vulnerabilities associated with climate change and ex-3 treme weather events, and to use all practicable means to 4 protect, manage, and conserve healthy, diverse, and pro-5 ductive fish, wildlife, and plant populations. 6 SEC. 3. DEFINITIONS. 7 In this Act: 8 ADAPTATION.—The term "adaptation" 9 means— 10 (A) the process of adjustment to actual or 11 expected climate and the effects of climate 12 change; and 13 (B) with respect to fish, wildlife, and 14 plants, protection, management, and conserva-15 tion efforts designed to maintain or enhance the 16 ability of fish, wildlife, and plants to withstand, 17 adjust to, or recover from the effects of extreme 18 weather and climate change (including, where 19 applicable, ocean acidification, drought, flood-20 ing, and wildfire). (2) CENTER.—The term "Center" means the 21 22 National Climate Change and Wildlife Science Center established under section 6(a)(1). 23 24 (3)COMMITTEE.—The term "Committee"

means the Advisory Committee on Climate Change

1	and Natural Resource Sciences established under
2	section $6(b)(1)$.
3	(4) Ecological processes.—The term "eco-
4	logical processes" means biological, chemical, or
5	physical interaction between the biotic and abiotic
6	components of an ecosystem, including—
7	(A) decomposition;
8	(B) disease epizootiology;
9	(C) disturbance regimes, such as fire and
10	flooding;
11	(D) gene flow;
12	(E) hydrological cycling;
13	(F) larval dispersal and settlement;
14	(G) nutrient cycling;
15	(H) pollination;
16	(I) predator-prey relationships; and
17	(J) soil formation.
18	(5) Habitat.—The term "habitat" means the
19	physical, chemical, and biological properties that
20	fish, wildlife, or plants use for growth, reproduction,
21	survival, food, water, or cover (whether on land, in
22	water, or in an area or region).
23	(6) Habitat connectivity.—The term "habi-
24	tat connectivity" means areas that facilitate terres-

1	trial, marine, estuarine, and freshwater fish, wildlife,
2	or plant movement that is necessary—
3	(A) for migration, gene flow, or dispersal;
4	or
5	(B) to respond to the ongoing and ex-
6	pected effects of climate change (including,
7	where applicable, ocean acidification, drought,
8	flooding, and wildfire).
9	(7) Indian Tribe.—The term "Indian Tribe"
10	has the meaning given the term in section 4 of the
11	Indian Self-Determination and Education Assistance
12	Act (25 U.S.C. 5304(e)).
13	(8) National Strategy.—The term "National
14	Strategy" means the National Fish, Wildlife, and
15	Plants Climate Adaptation Strategy released March
16	26, 2013.
17	(9) Resilience; resilient.—The terms "re-
18	silience" and "resilient" mean the ability to antici-
19	pate, prepare for, and adapt to changing conditions
20	and withstand, respond to, and recover rapidly from
21	disruptions.
22	(10) State.—The term "State" means—
23	(A) a State of the United States;
24	(B) the District of Columbia;
25	(C) American Samoa;

1	(D) Guam;
2	(E) the Commonwealth of the Northern
3	Mariana Islands;
4	(F) the Commonwealth of Puerto Rico;
5	and
6	(G) the United States Virgin Islands.
7	(11) Working Group.—The term "Working

9	SEC. 5. NATIONAL FISH, WILDLIFE, AND PLANTS CLIMATE
10	ADAPTATION STRATEGY.
11	(a) In General.—The Working Group shall adopt
12	the National Strategy to protect, manage, and conserve
13	fish, wildlife, and plants to maintain the inherent resil-
14	ience and adaptability of fish, wildlife, and plants to with-
15	stand the ongoing and expected effects of extreme weather
16	and climate change.
17	(b) REVIEW AND REVISION.—Not later than 1 year
18	after each release of the assessment required under section
19	106 of the Global Change Research Act of 1990 (15
20	U.S.C. 2936), the Working Group shall—
21	(1) use sound science to review and revise the
22	National Strategy to incorporate—
23	(A) new information regarding the ongoing
24	and expected effects of climate change on fish,
25	wildlife, and plants; and

1	(B) advances in the development of fish,
2	wildlife, and plant adaptation strategies; and
3	(2) in carrying out paragraph (1), provide pub-
4	lic notice and opportunity for comment.
5	(c) Contents.—A revised National Strategy shall—
6	(1) assess the vulnerability of fish, wildlife, and
7	plants to climate change, including short-term, me-
8	dium-term, long-term, and cumulative impacts;
9	(2) describe current observation and monitoring
10	activities at the Federal, State, Tribal, and local lev-
11	els relating to the ongoing and expected effects of
12	climate change on fish, wildlife, and plants;
13	(3) identify and prioritize research and data
14	needs;
15	(4) identify fish, wildlife, and plants likely to
16	have the greatest need for protection, restoration,
17	and conservation due to the ongoing and expanding
18	effects of extreme weather and climate change;
19	(5) include specific protocols for integrating
20	fish, wildlife, and plant adaptation strategies and ac-
21	tivities into the conservation and management of
22	natural resources by Federal agencies to ensure con-
23	sistency across agency jurisdictions;
24	(6) identify opportunities for maintaining, re-
25	storing, or enhancing fish, wildlife, and plants to re-

- duce the risks of extreme weather and climate change on other vulnerable sectors of society;
 - (7) identify Federal policies and actions that may reduce resilience and increase the vulnerability of fish, wildlife, and plants to extreme weather and climate change;
 - (8) include specific actions that Federal agencies shall take to protect, conserve, and manage fish, wildlife, and plants to maintain the inherent resilience and adaptability of fish, wildlife, and plants to withstand, adjust to, or recover from the ongoing and expected effects of climate change, including a timeline to implement those actions;
 - (9) include specific mechanisms for ensuring communication and coordination—
 - (A) among Federal agencies; and
 - (B) between Federal agencies and State agencies, territories of the United States, Indian Tribes, private landowners, conservation organizations, and other countries that share jurisdiction over fish, wildlife, and plants with the United States;
 - (10) include specific actions to develop and implement coordinated fish, wildlife, and plants inventory and monitoring protocols through interagency

- 1 coordination and collaboration with States and local 2 governments, Indian Tribes, and private organiza-3 tions; and
- (11) include procedures for guiding the develop-5 ment of detailed strategy implementation plans re-6 quired under section 7.

(d) Implementation.—

- (1) In General.—Consistent with other laws and Federal trust responsibilities concerning Indian land or rights of Indians under treaties with the United States, each Federal agency shall integrate the elements of the National Strategy that relate to conservation, management, and protection of fish, wildlife, and plants into agency plans, environmental reviews, and programs.
- Public Report.—The Working Group shall, on a biannual basis, between revisions to the National Strategy, make available to the public a report documenting any actions implementing the Strategy.
- (3) COORDINATION.—The Working Group shall coordinate the implementation of the National Strategy with Federal agencies not represented on the Working Group to achieve the policy of the United

 - (2) Consider and of Effects.—To the maximum extent practicable and consistent with existing authority, fish, wildlife, and plant conservation and management decisions made by each Federal agency shall consider and promote resilience to the
