1 AN ACT concerning

2 **Baltimore City – Alcoholic Beverages – B–D–7 Licenses – Hours of Sale**

3 FOR the purpose of altering a geographic boundary in the 45th alcoholic beverages district
4 of Baltimore City within which the holder of a B–D–7 beer, wine, and liquor license
5 must operate in accordance with specified hours; and generally relating to alcoholic
6 beverages in Baltimore City.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Alcoholic Beverages and Cannabis**

20 12–102.

3 (c) A holder of a Class B-D-7 beer, wine, and liquor license may sell beer, wine,
4 and liquor:

5 (1) from 9 a.m. to 9 p.m. in the area bounded by Liberty Heights Avenue,
6 Northern Parkway, Druid Park Drive, and Wabash Avenue;

7 (2) from 9 a.m. to 9 p.m. along the south side of Frederick Avenue between
8 South Augusta Avenue and South Loudon Avenue;

9 (3) from 9 a.m. to 10 p.m. in the area specified in the Park Heights Master
10 Plan adopted by the City in 2006; and

11 (4) from 9 a.m. to 10 p.m. in an area bounded [on the north by North
12 Avenue, on the west by Central Avenue and Harford Avenue, on the south by Monument
13 Street as it runs from North Central Avenue to North Wolfe Street and McElderry Street
14 as it runs from North Wolfe Street to Luzerne Avenue, and on the east by Luzerne Avenue
15 as it runs from Monument Street to Federal Street, then by Rose Street as it runs from
16 Federal Street to North Avenue] **AS FOLLOWS: FROM THE INTERSECTION OF EAST
17 NORTH AVENUE AND HARFORD AVENUE, SOUTHWEST ON HARFORD AVENUE TO
18 THE INTERSECTION OF HARFORD AVENUE AND NORTH CENTRAL AVENUE, SOUTH
19 ON NORTH CENTRAL AVENUE TO THE INTERSECTION WITH EAST MONUMENT
20 STREET, EAST ON EAST MONUMENT STREET TO THE INTERSECTION OF EAST
21 MONUMENT STREET AND NORTH WOLFE STREET, SOUTH ON NORTH WOLFE
22 STREET TO THE INTERSECTION OF NORTH WOLFE STREET AND MCELDERRY
23 STREET, EAST ON MCELDERRY STREET TO THE INTERSECTION OF MCELDERRY
24 STREET AND NORTH MONTFORD AVENUE, SOUTH ON NORTH MONTFORD AVENUE
25 TO THE INTERSECTION OF NORTH MONTFORD AVENUE AND ORLEANS STREET,
26 EAST ON ORLEANS STREET TO THE INTERSECTION OF ORLEANS STREET AND
27 NORTH LAKEWOOD AVENUE, NORTH ON NORTH LAKEWOOD AVENUE TO THE
28 INTERSECTION OF NORTH LAKEWOOD AVENUE AND EAST MONUMENT STREET,
29 WEST ON EAST MONUMENT STREET TO THE INTERSECTION OF EAST MONUMENT
30 STREET AND NORTH LUZERNE AVENUE, NORTH ON NORTH LUZERNE AVENUE TO
31 THE INTERSECTION OF NORTH LUZERNE AVENUE AND EAST FEDERAL STREET,
32 WEST ON EAST FEDERAL STREET TO THE INTERSECTION OF EAST FEDERAL
33 STREET AND NORTH ROSE STREET, NORTH ON NORTH ROSE STREET TO THE
34 INTERSECTION OF NORTH ROSE STREET AND EAST NORTH AVENUE, THEN WEST
35 ON EAST NORTH AVENUE TO THE INTERSECTION OF EAST NORTH AVENUE AND
36 HARFORD AVENUE; and**

37 (5) from 6 a.m. to 2 a.m. the following day in all other locations in the City.

2 (c) (1) This subsection does not apply to:

- 3 (i) a Class B beer and light wine license;
- 4 (ii) a Class B beer, wine, and liquor license;
- 5 (iii) a Class B-D-7 beer, wine, and liquor license;
- 6 (iv) a Class C beer and light wine license; and
- 7 (v) a Class C beer, wine, and liquor license.

8 (2) For a license holder in an area bounded by Liberty Heights Avenue,
9 Northern Parkway, Druid Park Drive, and Wabash Avenue, the hours of sale:

- 10 (i) may not begin before 9 a.m. or end after 10 p.m.; and
- 11 (ii) may not be extended if they begin later than 9 a.m. or end before
12 10 p.m.

13 (3) For a license holder in an area bounded [on the north by North Avenue,
14 on the west by Central Avenue and Harford Avenue, on the south by Monument Street as
15 it runs from North Central Avenue to North Wolfe Street and McElderry Street as it runs
16 from North Wolfe Street to Luzerne Avenue, and on the east by Luzerne Avenue as it runs
17 from Monument Street to Federal Street, then by Rose Street as it runs from Federal Street
18 to North Avenue] **AS FOLLOWS: FROM THE INTERSECTION OF EAST NORTH AVENUE
19 AND HARFORD AVENUE, SOUTHWEST ON HARFORD AVENUE TO THE INTERSECTION
20 OF HARFORD AVENUE AND NORTH CENTRAL AVENUE, SOUTH ON NORTH CENTRAL
21 AVENUE TO THE INTERSECTION WITH EAST MONUMENT STREET, EAST ON EAST
22 MONUMENT STREET TO THE INTERSECTION OF EAST MONUMENT STREET AND
23 NORTH WOLFE STREET, SOUTH ON NORTH WOLFE STREET TO THE INTERSECTION
24 OF NORTH WOLFE STREET AND MCELDERRY STREET, EAST ON MCELDERRY
25 STREET TO THE INTERSECTION OF MCELDERRY STREET AND NORTH MONTFORD
26 AVENUE, SOUTH ON NORTH MONTFORD AVENUE TO THE INTERSECTION OF NORTH
27 MONTFORD AVENUE AND ORLEANS STREET, EAST ON ORLEANS STREET TO THE
28 INTERSECTION OF ORLEANS STREET AND NORTH LAKEWOOD AVENUE, NORTH ON
29 NORTH LAKEWOOD AVENUE TO THE INTERSECTION OF NORTH LAKEWOOD
30 AVENUE AND EAST MONUMENT STREET, WEST ON EAST MONUMENT STREET TO
31 THE INTERSECTION OF EAST MONUMENT STREET AND NORTH LUZERNE AVENUE,
32 NORTH ON NORTH LUZERNE AVENUE TO THE INTERSECTION OF NORTH LUZERNE
33 AVENUE AND EAST FEDERAL STREET, WEST ON EAST FEDERAL STREET TO THE
34 INTERSECTION OF EAST FEDERAL STREET AND NORTH ROSE STREET, NORTH ON**

1 **NORTH ROSE STREET TO THE INTERSECTION OF NORTH ROSE STREET AND EAST**
2 **NORTH AVENUE, THEN WEST ON EAST NORTH AVENUE TO THE INTERSECTION OF**
3 **EAST NORTH AVENUE AND HARFORD AVENUE, the hours of sale:**

4 (i) may not begin before 9 a.m. or end after 10 p.m.; and

5 (ii) may not be extended if they begin later than 9 a.m. or end before
6 10 p.m.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
8 1, 2024.
