A BILL

To direct the Joint Committee on the Library to obtain a statue of Ruth Bader Ginsburg and to place the statue in the United States Capitol in National Statuary Hall.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. PLACEMENT OF STATUE OF RUTH BADER GINS-
- 4 BURG IN NATIONAL STATUARY HALL.
- 5 (a) Obtaining Statue.—Not later than 2 years
- 6 after the date of the enactment of this Act, the Joint Com-
- 7 mittee on the Library shall enter into an agreement to
- 8 obtain a statue or bust of Ruth Bader Ginsburg, under
- 9 such terms and conditions as the Joint Committee con-
- 10 siders appropriate consistent with applicable law.
- 11 (b) Placement.—The Joint Committee shall place
- 12 the statue or bust obtained under subsection (a) in the
- 13 United States Capitol in a suitable permanent location in
- 14 National Statuary Hall.
- 15 (c) Waiver of Waiting Period.—Section 2(a) of
- 16 Public Law 109–116 (2 U.S.C. 2131a(a)) does not apply
- 17 with respect to the statue or bust obtained and placed
- 18 under subsection (a).

1 SEC. 2. AUTHORIZATION OF APPROPRIATIONS.

- 2 There are authorized to be appropriated such sums
- 3 as may be necessary to carry out this Act, and any
- 4 amounts so appropriated shall remain available until ex-

5 pended.
