### LONG TITLE

#### 4 General Description:

- 5 This bill amends provisions related to license plates, including requirements for display,
- 6 fees, distribution, design, and funding.

## **7 Highlighted Provisions:**

- 8 This bill:
- 9 removes the requirement for the Motor Vehicle Division to issue two license plates in most circumstances;
- removes the requirement for an owner of a vehicle to display a license plate on the front of a vehicle;
  - removes the requirement for two registration decals for both the month and year, and consolidates the registration information into one decal;
- requires a license plate design or redesign to be approved by the License Plate Design Review Board;
  - requires an additional fee for personalized license plates;
  - allows the Motor Vehicle Division to use funds in the License Plate Restricted Account for certain additional purposes;
  - ▶ allows an institution of higher education to design the collegiate special group license plate for the institution, subject to approval by the license plate design review board;
  - requires a person applying to create a new sponsored special group license plate to pay an additional fee to cover the costs of designing and administering the new license plate;
  - requires the Motor Vehicle Division to transition to central distribution of license plates;
- 25 ▶ amends certain design characteristics of license plates regarding embossing;
- prohibits a license plate cover and prohibits a license plate frame that obscures the
- 27 license plate number or decals;

Section 1. Section 13-48-103 is amended to read:

# 13-48-103 (Effective 01/01/25). Motor vehicle rental company -- Fee disclosure and collection requirements.

- (1) A motor vehicle rental company may include separately stated surcharges, fees, or charges in a rental agreement, including:
- 85 (a) motor vehicle license cost recovery fees;
- 86 (b) airport access fees;
- 87 (c) airport concession fees; and
- 88 (d) all applicable taxes.
- (2) If a motor vehicle rental company includes a motor vehicle license cost recovery fee as
   a separately stated charge in a rental transaction, the amount of the fee shall represent
   the motor vehicle rental company's good-faith estimate of the motor vehicle rental
   company's daily charge as calculated by the motor vehicle rental company to recover its
   actual total annual motor vehicle titling, registration, obtaining [license plates] a license
   plate, and motor vehicle inspection and emission costs.
  - (3) If the total amount of the motor vehicle license cost recovery fees collected by a motor

192	(1) For purposes of this section, "registrant" means an owner or operator of one or more
193	commercial vehicles operating in two or more jurisdictions applying for apportioned
194	registration and licensing of a commercial vehicle.
195	(2) (a) An owner or operator of a fleet of commercial vehicles based in this state and
196	operating in two or more jurisdictions may register commercial vehicles for operation
197	under the International Registration Plan or the Uniform Vehicle Registration

198	Proration and Reciprocity Agreement by filing an application with the division.
199	(b) The application shall include information that identifies the vehicle owner, the
200	vehicle, the miles traveled in each jurisdiction, and other information pertinent to the
201	registration of apportioned vehicles.

204	(3) (a) If no operations were conducted during the preceding year, in computing fees due:
205	(i) the application shall contain a statement of the proposed operations; and
206	(ii) the division shall determine fees based on average per vehicle distance
207	requirements under the International Registration Plan.
208	(b) At renewal, the registrant shall use the actual mileage from the preceding year in
209	computing fees due each jurisdiction.
210	(4) The division shall determine the registration fee for apportioned vehicles as follows:
211	(a) divide the in-jurisdiction miles by the total miles generated during the preceding year;
212	(b) total the fees for each vehicle based on the fees prescribed in Section 41-1a-1206; and
213	(c) multiply the sum obtained under Subsection (4)(b) by the quotient obtained under
214	Subsection (4)(a).
215	(5) The registrant may list trailers or semitrailers of apportioned fleets separately as "trailer
216	fleets" on the application, with the fees paid according to the total distance those trailers
217	were towed in all jurisdictions during the preceding year mileage reporting period.
218	(6) (a) (i) When the registrant has paid the proper fees and cleared the property tax or
219	in lieu fee under Section 41-1a-206 or 41-1a-207, the division shall issue a
220	registration card and license plate for each unit listed on the application.
221	(ii) The owner or operator shall carry an original registration in each vehicle at all
222	times.
223	(b) The owner or operator may carry original registration cards for trailers or semitrailers
224	in the power unit.
225	(c) (i) In lieu of a permanent registration card or license plate, the division may issue
226	one temporary permit authorizing operation of new or unlicensed vehicles until
227	the permanent registration is completed.
228	(ii) Once a temporary permit is issued:
229	(A) neither the registrant nor the division may cancel the registration process; and
230	(B) the division shall complete registration and the registrant shall pay the fees
231	and any property tax or in lieu fee due for the vehicle for which the permit was

232	issued.
233	(iii) The division may not issue temporary permits for renewals.
234	(d) (i) The division shall issue one distinctive license plate for apportioned vehicles.
235	(ii) The owner or operator shall display the plate on the front of an apportioned truck
236	tractor or power unit or on the rear of any other apportioned vehicle.
237	(iii) (A) The division shall issue distinctive decals or a distinctive license plate
238	displaying the word "apportioned" or the abbreviation "APP" for each
239	apportioned vehicle.
240	(B) A registrant of an apportioned vehicle is not required to display [month or
241	year decals] a registration decal.
242	(iv) At the request of a registrant of an apportioned vehicle, the division may issue a
243	second license plate, for a total of two, to display on both the front and rear of the
244	apportioned vehicle.
245	(e) The division shall charge a nonrefundable administrative fee, determined by the
246	commission pursuant to Section 63J-1-504, for each temporary permit, registration,
247	or both.
248	(7) Vehicles that are apportionally registered are fully registered for intrastate and interstate
249	movements, providing the registrant has secured proper interstate and intrastate
250	authority.
251	(8) (a) The division shall register vehicles added to an apportioned fleet after the
252	beginning of the registration year by applying the quotient under Subsection (4)(a)
253	for the original application to the fees due for the remainder of the registration year.
254	(b) (i) The owner shall maintain and submit complete annual mileage for each vehicle
255	in each jurisdiction, showing all miles operated by the lessor and lessee.
256	(ii) The fiscal mileage reporting period begins July 1, and continues through June 30
257	of the year immediately preceding the calendar year in which the registration year
258	begins.
259	(c) (i) An owner-operator, who is a lessor, may register the vehicle in the name of the
260	owner-operator.
261	(ii) The identification plates and registration card shall be the property of the lessor
262	and may reflect both the owner-operator's name and that of the carrier as lessee.

273	for deficiencies, or allowances for credits, the registrant shall provide the records to
274	the division.
275	(c) The division may not make an assessment for deficiency or claim for credit for any
276	period for which records are no longer required.
277	(d) The division may assess interest in the amount prescribed by Section 59-1-402 from
278	the date due until paid on deficiencies found due after audit.
279	(e) Registrants with deficiencies are subject to the penalties under Section 59-1-401.
280	(f) The division may enter into agreements with other International Registration Plan
281	jurisdictions for joint audits.
282	(10) (a) Except as provided in Subsection (10)(b), the division shall deposit all state fees
283	collected under this section in the Transportation Fund.
284	(b) The commission may use the following fees as a dedicated credit to cover the costs
285	of electronic credentialing as provided in Section 41-1a-303:

296	new vehicle is heavier than the replaced vehicle, the division shall assess
297	additional registration fees.
298	(iii) If the registrant is replacing a vehicle for one withdrawn from the fleet, the
299	division shall issue a new registration card

(b) If a vehicle is withdrawn from an apportioned fleet during the period for which it is registered, the registrant shall notify the division and surrender the registration card and license plate of the withdrawn vehicle.

- (b) For registration described in Subsection (12)(a), the division shall assess fees as provided in Section 41-1a-1207.
- (13) (a) Commercial vehicles meeting the registration requirements of another jurisdiction may, as an alternative to full or apportioned registration, secure a temporary registration permit for a period not to exceed 96 hours or until they leave
