A BILL

To amend the Social Security Act to place limitations on recovery of overpayments under titles II and XVI.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Protecting Americans
- 5 from Social Security Clawbacks Act".
- 6 SEC. 2. LIMITATION ON RECOVERY OF OVERPAYMENTS.
- 7 (a) TITLE II AMENDMENT.—
- 8 (1) In General.—Section 204(a)(1)(A) of the
- 9 Social Security Act (42 U.S.C. 404(a)(1)(A)) is
- 10 amended—

1	(A) by striking "With respect" and insert-
2	ing "(i) With respect"; and
3	(B) by adding at the end the following:
4	"(ii) In any case in which the Commissioner
5	finds that more than the correct amount of payment
6	has been made to a person, recovery from the person
7	may not be made if—
8	"(I) the overpayment occurred more than
9	3 years before the date of the finding; and
10	"(II) the overpayment was a result of error
11	on the part of the Commissioner.
12	"(iii) Clause (ii) shall not apply to a person if
13	the Commissioner determines that the person has
14	ever committed fraud or similar fault with respect to
15	the program under this title.".
16	(2) Conforming Amendment.—Section
17	204(a)(2) of such Act (42 U.S.C. $404(a)(2)$) is
18	amended by striking "Notwithstanding" and insert-
19	ing "Subject to clauses (ii) and (iii) of paragraph
20	(1)(A), but notwithstanding".
21	(b) TITLE XVI AMENDMENTS.—
22	(1) In General.—Section 1631(b)(1) of such
23	Act (42 U.S.C. 1383(b)(1)) is amended by adding at
24	the end the following:

- 1 "(C)(i) In any case in which the Commissioner finds
- 2 that more than the correct amount of payment has been
- 3 made to a person, recovery from the person may not be
- 4 made if—
- 5 "(I) the overpayment occurred more than 3
- 6 years before the date of the finding; and
- 7 "(II) the overpayment was a result of error on
- 8 the part of the Commissioner.
- 9 "(ii) Clause (i) shall not apply to a person if the Com-
- 10 missioner determines that the person has ever committed
- 11 fraud or similar fault with respect to the program under
- 12 this title.".
- 13 (2) Conforming amendment.—Section
- 14 1631(b)(2) of such Act (42 U.S.C. 1383(b)(2)) is
- amended by striking "Notwithstanding" and insert-
- ing "Subject to paragraph (1)(C), but notwith-
- standing".
