Correctional Officers' Retirement System - Membership

- 3 FOR the purpose of altering the membership of the Correctional Officers' Retirement 4 System to include certain individuals serving in certain positions in the Department of Public Safety and Correctional Services and the Department of Juvenile Services; providing that certain members of the Correctional Officers' Retirement System who meet certain criteria may receive a normal service retirement allowance that is based on certain creditable service; requiring the State Retirement Agency, on or before a certain date, to notify certain individuals affected by this Act of their rights to transfer certain service credit to the Correctional Officers' Retirement System; and generally relating to membership in the Correctional Officers' Retirement System.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 31 $\,$ 1, 2017.
