Mr. Bilirakis introduced the following bill; which was referred to the Committee on Veterans' Affairs

A BILL

To direct the Secretary of Veterans Affairs to establish a pilot program for the provision of dental care to certain veterans, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Veterans Early Treat-
- 5 ment for Chronic Ailment Resurgence through Examina-
- 6 tions Act of 2017" or the "VET CARE Act of 2017".
- 7 SEC. 2. PILOT PROGRAM FOR THE PROVISION OF DENTAL
- 8 CARE TO CERTAIN VETERANS.
- 9 (a) PILOT PROGRAM.—The Secretary of Veterans Af-
- 10 fairs shall carry out a pilot program to provide outpatient

- 1 dental services and treatment, and related dental appli-
- 2 ances, to eligible veterans enrolled under subsection (c)(3),
- 3 at no cost to such veterans. Under the pilot program, the
- 4 Secretary shall determine whether there is a correlation
- 5 between veterans receiving such services and treatment,
- 6 and the veterans suffering fewer complications of chronic
- 7 ailments, thereby yielding a lower cost of care.
- 8 (b) Eligible Veterans Defined.—For purposes
- 9 of this section, the term "eligible veterans" means vet-
- 10 erans who are—
- 11 (1) enrolled in the system of annual patient en-
- 12 rollment under section 1705 of title 38, United
- 13 States Code;
- 14 (2) not eligible for dental care under section
- 15 1712 of title 38, United States Code;
- 16 (3) between 40 and 70 years of age; and
- 17 (4) diagnosed with type 2 diabetes.
- 18 (c) Application; Evaluation; Disqualification;
- 19 Enrollment; Categorization.—
- 20 (1) Application.—Eligible veterans may elect
- 21 to apply for the pilot program.
- 22 (2) EVALUATION; DISQUALIFICATION.—Eligible
- veterans who apply for the pilot program shall re-
- ceive an initial periodontal evaluation, including
- vertical bitewing radiographs. Any eligible veteran

- 1 diagnosed with periodontal disease that requires sur-2 gery shall be disqualified from the pilot program.
- 3 (3) ENROLLMENT; CATEGORIZATION.—The Sec-4 retary shall enroll at least 1,500 eligible veterans 5 who apply for the pilot program, giving preference to 6 veterans with service-connected disabilities that in-7 creases in accordance with the veterans' disability 8 ratings under chapter 11 of title 38, United States 9 Code, in a manner that ensures the following:
- 10 (A) One-third of eligible veterans enrolled 11 in the pilot program shall have been diagnosed 12 with no or mild periodontitis under paragraph 13 (2).
- 14 (B) Two-thirds of eligible veterans enrolled 15 in the pilot program shall have been diagnosed 16 with moderate to severe periodontitis under 17 paragraph (2).
- 18 (d) DURATION OF PROGRAM.—The Secretary shall 19 carry out the pilot program during the four-year period 20 beginning on the date that is 180 days after the effective 21 date of this section.
- 22 (e) LOCATIONS.—The pilot program shall be carried 23 out in five facilities of the Veterans Health Administra-24 tion, with one such facility in each of five Veterans Inte-

- 1 grated Services Networks that the Secretary considers ap-
- 2 propriate for the pilot program.
- 3 (f) Patient Distribution.—Each facility shall
- 4 serve not more than one-fourth and not fewer than one-
- 5 sixth of the veterans enrolled in the pilot program, in ap-
- 6 proximately even proportions of veterans categorized
- 7 under subsection (c)(3).
- 8 (g) Course of Program.—
- 9 (1) Periodontal Therapy.—The Secretary
- shall make timely and appropriate periodontal ther-
- apy available to veterans described in subsection
- 12 (c)(3)(B).
- 13 (2) Election of treatment.—Such veterans
- who elect to receive treatment shall be classified as
- "treated".
- 16 (3) Annual Evaluations.—Each treated vet-
- eran shall receive an annual dental evaluation, dur-
- ing which the periodontal health of the treated vet-
- eran shall be reassessed and recorded exactly as at
- the initial evaluation under subsection (c)(2).
- 21 (4) HEALTH OUTCOME REPORTING.—For the
- duration of the pilot program, the Secretary shall
- collect and record data regarding the health of treat-
- 24 ed veterans, including events, treatments, and out-

comes, and make such data available for analysis by
qualified researchers.

- (1) HEALTH CARE PROVIDERS.—The Secretary shall provide standardized instructions to all physicians and dentists who work in facilities described in subsection (e) to ensure consistent evaluation and care for veterans enrolled in the pilot program in all such facilities.
- 10 (2)ENROLLED VETERANS.—The Secretary 11 shall provide each veteran enrolled in the pilot pro-12 gram with an orientation, information before any 13 care is provided under the pilot program, and an 14 exit interview that includes information regarding 15 how such veteran may obtain dental services and 16 treatment after the end of the pilot program.
- 17 (i) EDUCATIONAL OUTREACH.—The Secretary shall notify those institutions of higher education (as that term 18 is defined in section 102 of the Higher Education Act of 19 20 1965 (20)U.S.C. 1002))that offer degrees 21 periodontology of the pilot program so that such institutions may engage in similar studies regarding private peri-23 odontal care for veterans.

- 1 (j) REPORT.—Not later than 18 months after the
- 2 conclusion of the pilot program, the Secretary shall submit
- 3 a report of findings to the Congress.
- 4 (k) REGULATIONS.—The Secretary shall administer
- 5 the pilot program under such regulations as the Secretary
- 6 shall prescribe, including best practices regarding in-
- 7 formed consent and study registration.
