A BILL

To manage supply chain risk through counterintelligence
training, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Supply Chain Security
5 Training Act of 2021”.

1 **SEC. 2. TRAINING PROGRAM TO MANAGE SUPPLY CHAIN**
2 **RISK.**

3 (a) IN GENERAL.—Not later than 180 days after the
4 date of the enactment of this Act, the Administrator of
5 General Services, through the Federal Acquisition Insti-
6 tute, shall develop a training program for officials with
7 supply chain risk management responsibilities at ~~executive~~
8 *Federal* agencies.

9 (b) CONTENT.—The training program shall be de-
10 signed to prepare such personnel to perform supply chain
11 risk management activities and identify and mitigate sup-
12 ply chain security threats that arise throughout the acqui-
13 sition lifecycle, including for the acquisition of information
14 and communications technology. The training program
15 shall—

16 (1) include, considering the protection of classi-
17 fied and other sensitive information, information on
18 current, specific supply chain security threats; and

19 (2) be updated as determined to be necessary
20 by the Administrator.

21 (c) COORDINATION AND CONSULTATION.—In devel-
22 oping the training program, the Administrator shall—

23 (1) coordinate with the Federal Acquisition Se-
24 curity Council, the Secretary of Homeland Security,
25 and the Director of the Office of Personnel Manage-
26 ment; and

1 (2) consult with the Director of the Department
 2 of Defense's Defense Acquisition University and the
 3 Director of National Intelligence.

4 (d) GUIDANCE.—

5 (1) *IN GENERAL*.—Not later than 180 days
 6 after the training program is developed under sub-
 7 section (a), the Director of the Office of Manage-
 8 ment and Budget shall promulgate guidance to Fed-
 9 eral agencies requiring executive agency adoption
 10 and use of the training program. Such guidance
 11 shall—

12 ~~(1)~~ (A) allow executive agencies to incor-
 13 porate the training program into existing agen-
 14 cy training programs; and

15 ~~(2)~~ (B) provide guidance on how to identify
 16 executive agency officials with supply chain risk
 17 management responsibilities.

18 (2) *AVAILABILITY*.—*The Director of the Office of*
 19 *Management and Budget shall make the guidance*
 20 *promulgated under paragraph (1) available to Fed-*
 21 *eral agencies of the legislative and judicial branches.*

22 **SEC. 3. REPORTS ON IMPLEMENTATION OF PROGRAM.**

23 Not later than 180 days after the completion of the
 24 first course, and annually thereafter for the next three
 25 years, the Administrator of General Services shall submit

1 to the appropriate congressional committees and leader-
 2 ship a report on implementation of the training program
 3 required under section 2.

4 **SEC. 4. DEFINITIONS.**

5 In this Act:

6 (1) **APPROPRIATE CONGRESSIONAL COMMIT-**
 7 **TEES AND LEADERSHIP.**—The term “appropriate
 8 congressional committees” means—

9 (A) the Committee on Homeland Security
 10 and Governmental Affairs and the Committee
 11 on Armed Services of the Senate; and

12 (B) the Committee on Oversight and Re-
 13 form and the Committee on Armed Services of
 14 the House of Representatives.

15 (2) **INFORMATION AND COMMUNICATIONS**
 16 **TECHNOLOGY.**—The term “information and commu-
 17 nications technology” has the meaning given the
 18 term in section 4713(k) of title 41, United States
 19 Code.

20 (3) **EXECUTIVE AGENCY.**—The term “executive
 21 agency” has the meaning given the term in section
 22 133 of title 41, United States Code.

23 (4) *FEDERAL AGENCY.*—*The term “Federal agen-*
 24 *cy” means any agency, committee, commission, office,*

1 *or other establishment in the executive, legislative, or*
2 *judicial branch of the Federal Government.*

3 ~~(4)~~(5) TRAINING PROGRAM.—The term “train-
4 ing program” means the training program developed
5 pursuant to section 2(a).
