A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Sign Language Interpreters Act**

3 FOR the purpose of establishing a licensing and regulatory system for sign language
4 interpreters under the State Board of Sign Language Interpreters in the Office of the
5 Deaf and Hard of Hearing; and generally relating to the licensing of sign language
6 interpreters and the State Board of Sign Language Interpreters.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That Section(s) 8–403(59) through (63) of Article – State Government of the Annotated Code of Maryland be renumbered to be Section(s) 8–403(60) through (64), respectively.

SECTION 2. AND BE IT FURTHER ENACTED, That the new part designation “Part II. Office of the Deaf and Hard of Hearing” be added to immediately precede Section 9–2402 of Article – State Government of the Annotated Code of Maryland.

SECTION 3. AND BE IT FURTHER ENACTED, That the Laws of Maryland read as follows:

Article – State Government

8–403.

This subtitle applies only to the following governmental activities and units:

(59) SIGN LANGUAGE INTERPRETERS, STATE BOARD OF (§ 9–2410 OF THIS ARTICLE);

PART I. DEFINITIONS.

9–2401.

(a) In this subtitle the following words have the meanings indicated.

(B) “AMERICAN SIGN LANGUAGE” MEANS A VISUAL–SPATIAL METHOD OF COMMUNICATION THAT IS A DISTINCT LANGUAGE INVOLVING THE HANDS, ARMS, FACIAL MARKERS, AND BODY MOVEMENTS TO COMMUNICATE WITH OTHERS, INCLUDING THROUGH THE CONVEYANCE OF THOUGHTS, WORDS, EMOTIONS, AND GRAMMATICAL INFORMATION.

(C) “BEHAVIORAL HEALTH SETTING” MEANS A SETTING THAT PROVIDES:

(1) PSYCHIATRIC OR PSYCHOLOGICAL ASSESSMENT OR SCREENING;

(2) GROUP OR INDIVIDUAL PSYCHOTHERAPY, COUNSELING, OR TREATMENT; OR

(3) REHABILITATION SERVICES FOR SUBSTANCE USE DISORDERS, ADDICTIVE DISORDERS, MENTAL DISORDERS, OR A COMBINATION OF THESE DISORDERS.

(D) “BOARD” MEANS THE STATE BOARD OF SIGN LANGUAGE INTERPRETERS WITHIN THE OFFICE.

1 **[(b)] (E)** “Council” means the Maryland Advisory Council on Deaf and Hard of
2 Hearing Individuals.

3 **[(c)] (F)** (1) “Deaf and hard of hearing individuals” means those residents of
4 Maryland who have a partial or complete loss of hearing.

5 (2) “Deaf and hard of hearing individuals” includes individuals who are
6 deaf, hard of hearing, deafblind, and late-deafened.

7 **[(d)] (G)** “Deafblind” means those residents of Maryland who have concomitant
8 vision and hearing loss.

9 **[(e)] (H)** “Director” means the Director of the Office.

10 **(I)** **“FUND” MEANS THE SIGN LANGUAGE INTERPRETERS FUND.**

11 **(J)** **“HERITAGE SIGNER” MEANS AN INDIVIDUAL WHO USED AMERICAN**
12 **SIGN LANGUAGE AS A PRIMARY LANGUAGE IN CHILDHOOD.**

13 **(K)** **“LEGAL SETTING” INCLUDES:**

14 **(1)** **COURT PROCEEDINGS;**

15 **(2)** **ATTORNEY-CLIENT CONFERENCES;**

21 **(L)** **“LICENSE” MEANS A LICENSE ISSUED UNDER PART III OF THIS**
22 **SUBTITLE TO PROVIDE SIGN LANGUAGE INTERPRETATION SERVICES.**

23 **(M)** **“MEDICAL SETTING” INCLUDES:**

24 **(1)** **AN ACUTE CARE HOSPITAL;**

25 **(2)** **AN URGENT CARE CENTER;**

1 **(3) AN OUTPATIENT CLINIC;**

2 **(4) SHORT-TERM CARE FACILITIES;**

3 **(5) LONG-TERM CARE FACILITIES;**

4 **(6) A PHYSICIAN'S OFFICE; AND**

5 **(7) HOME HEALTH CARE.**

6 **(N) "NATIONALLY OR REGIONALLY RECOGNIZED CERTIFICATION" MEANS:**

7 **(1) A CERTIFICATION ISSUED AND RECOGNIZED BY:**

8 **(I) THE NATIONAL ASSOCIATION OF THE DEAF (NAD);**

9 **(II) THE REGISTRY OF INTERPRETERS FOR THE DEAF (RID);**

10 **OR**

11 **(III) THE BOARD OF EVALUATION FOR INTERPRETERS (BEI);**

12 **OR**

13 **(2) ANY OTHER CERTIFICATION ISSUED BY A NATIONAL OR REGIONAL**
14 **ORGANIZATION THAT IS RECOGNIZED BY THE BOARD.**

15 **[(f)] (O) "Office" means the Office of the Deaf and Hard of Hearing.**

16 **(P) (1) "PROVIDE SIGN LANGUAGE INTERPRETATION SERVICES" MEANS**
17 **TO CONVEY THE MEANING OF A MESSAGE THAT IS EXPRESSED IN:**

18 **(I) AN ORAL OR SIGNED LANGUAGE BY RENDERING THE**
19 **MESSAGE IN AMERICAN SIGN LANGUAGE; OR**

20 **(II) AMERICAN SIGN LANGUAGE BY RENDERING THE MESSAGE**
21 **IN AN ORAL OR SIGNED LANGUAGE.**

22 **(2) "PROVIDE SIGN LANGUAGE INTERPRETATION SERVICES"**
23 **INCLUDES PROVIDING SIGN LANGUAGE INTERPRETATION SERVICES IN A VIDEO**
24 **REMOTE INTERPRETING SETTING.**

25 **(Q) "RESTORATIVE JUSTICE PROGRAM" MEANS A PROGRAM DESIGNED TO**
26 **REPAIR HARM CAUSED TO ALL INDIVIDUALS INVOLVED IN A CRIME THROUGH**

1 MEDIATION, DIALOGUE, OR GROUP CONFERENCING BETWEEN A LICENSEE AND ANY
2 AGGRIEVED PARTY OR COMPLAINANT.

3 (R) "SCHOOL SETTING" MEANS A SETTING IN WHICH THE FOLLOWING ARE
4 PROVIDED:

5 (1) EDUCATIONAL PROGRAMS OR SERVICES OFFERED BY A PUBLIC
6 OR NONPUBLIC SCHOOL; OR

7 (2) CAREER TRAINING PROGRAMS FOR SECONDARY EDUCATION
8 STUDENTS THAT ARE REGULATED BY THE STATE DEPARTMENT OF EDUCATION.

9 (S) "SIGN LANGUAGE INTERPRETER" MEANS AN INDIVIDUAL WHO IS
10 LICENSED BY THE BOARD TO PROVIDE SIGN LANGUAGE INTERPRETATION
11 SERVICES.

12 (T) "VIDEO RELAY SERVICE" MEANS THE FEDERALLY REIMBURSED AND
13 REGULATED PROGRAM ESTABLISHED TO ENABLE PHONE CALLS BETWEEN USERS OF
14 AMERICAN SIGN LANGUAGE AND INDIVIDUALS WHO DO NOT USE AMERICAN SIGN
15 LANGUAGE BY VIDEOCONFERENCING TECHNOLOGY AND THE USE OF THE SERVICES
16 OF A REMOTELY LOCATED SIGN LANGUAGE INTERPRETER.

17 (U) (1) "VIDEO REMOTE INTERPRETING SETTING" MEANS PROVIDING
18 SIGN LANGUAGE INTERPRETATION SERVICES BY VIDEOCONFERENCING IN WHICH
19 THE PARTICIPANTS ARE IN ONE LOCATION AND THE INTERPRETER IS IN A SEPARATE
20 LOCATION.

21 (2) "VIDEO REMOTE INTERPRETING SETTING" DOES NOT INCLUDE
22 VIDEO RELAY SERVICE.

23 9-2403.

24 (a) The Office shall be responsible for promoting the general welfare of deaf and
25 hard of hearing individuals in the State.

26 (b) The responsibilities of the Office shall include:

27 (1) providing, advocating, and coordinating the adoption of public policies,
28 regulations, and programs that will benefit deaf and hard of hearing individuals;

29 (2) improving access to communication and to existing services and
30 programs for deaf and hard of hearing individuals;

31 (3) providing direct services to deaf and hard of hearing individuals as

appropriate;

(4) increasing public awareness of the needs and issues affecting deaf and hard of hearing individuals;

(5) working with State and local agencies to ensure access for deaf and hard of hearing individuals to safety and emergency services;

(6) developing a referral service for deaf and hard of hearing individuals;

(7) serving as an information clearinghouse on the needs and issues affecting deaf and hard of hearing individuals;

(8) working to increase access for deaf and hard of hearing individuals to educational, health, and social opportunities;

(9) working with private organizations, the federal government, and other units of State government to promote economic development for deaf and hard of hearing individuals;

(10) working to eliminate the underemployment and unemployment of deaf and hard of hearing individuals;

(11) providing a network through which services provided by State and federal programs serving deaf and hard of hearing individuals can be channeled; [and]

(12) promoting compliance with State, local, and federal laws and policies protecting and serving deaf and hard of hearing individuals;

(13) PROVIDING APPROPRIATE STAFF TO ASSIST THE BOARD IN CARRYING OUT ITS DUTIES; AND

(14) PROVIDING A NOMINATION PROCESS FOR BOARD APPOINTMENTS.

(c) The Office shall hold at least two public town hall meetings each year to receive public comments on:

(1) the quality of State services and programs affecting deaf and hard of hearing individuals;

(2) the functions and operations of the Office; and

(3) any other issues that affect deaf and hard of hearing individuals, including those specified in subsection (b) of this section.

(d) The Office shall:

(1) help facilitate the appropriate delivery of State, local, and other public services to deaf and hard of hearing individuals;

(2) advise other units of State government and the General Assembly on the needs of deaf and hard of hearing individuals;

(3) subject to appropriations in the State budget, provide any reasonable resources that any other unit of State government requests to serve or assist deaf and hard of hearing individuals; and

(4) to the greatest extent possible, in order to avoid any duplication of effort, coordinate with other units of the State and the federal government the services provided to deaf and hard of hearing individuals.

PART III. SIGN LANGUAGE INTERPRETERS.

THERE IS A STATE BOARD OF SIGN LANGUAGE INTERPRETERS IN THE OFFICE.

9-2411.

(A) (1) THE BOARD CONSISTS OF SEVEN MEMBERS APPOINTED BY THE GOVERNOR.

(2) OF THE SEVEN MEMBERS:

(I) ONE SHALL BE A MEMBER OF THE MARYLAND ASSOCIATION OF THE DEAF;

(II) ONE SHALL BE A DEAFBLIND INDIVIDUAL;

(III) ONE SHALL BE A MEMBER OF THE POTOMAC CHAPTER OF THE REGISTRY OF THE INTERPRETERS FOR THE DEAF WHO HOLDS A LICENSE UNDER THIS PART; AND

(IV) FOUR SHALL BE DETERMINED BY THE BOARD BY REGULATION.

(3) (I) THE GOVERNOR SHALL APPOINT THE MEMBERS FROM A LIST OF NAMES SUBMITTED FROM A NOMINATION PROCESS ESTABLISHED BY THE OFFICE.

(II) TO THE EXTENT PRACTICABLE, THE MEMBERS APPOINTED UNDER THIS SECTION SHALL REFLECT THE RACIAL AND GEOGRAPHIC DIVERSITY OF THE STATE.

(B) EACH MEMBER SHALL:

(1) BE A RESIDENT OF THE STATE; AND

(2) BE PROFICIENT IN AMERICAN SIGN LANGUAGE.

(C) BEFORE TAKING OFFICE, EACH MEMBER APPOINTED TO THE BOARD SHALL TAKE THE OATH OR AFFIRMATION REQUIRED BY ARTICLE I, § 9 OF THE MARYLAND CONSTITUTION.

(D) (1) THE TERM OF A BOARD MEMBER IS 2 YEARS, BEGINNING ON THE DATE OF APPOINTMENT.

(2) AT THE END OF A TERM, A MEMBER CONTINUES TO SERVE UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.

(3) A MEMBER APPOINTED AFTER A TERM HAS BEGUN SERVES ONLY FOR THE REMAINDER OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.

(4) A MEMBER MAY NOT SERVE MORE THAN THREE CONSECUTIVE FULL TERMS.

(E) (1) THE GOVERNOR MAY REMOVE A MEMBER FOR INCOMPETENCE, MISCONDUCT, NEGLECT OF DUTIES, OR OTHER SUFFICIENT CAUSE.

(2) THE GOVERNOR SHALL REMOVE A MEMBER WHO:

(I) CEASES TO MEET THE REQUIREMENTS UNDER WHICH THE MEMBER WAS APPOINTED UNDER SUBSECTION (A) OF THIS SECTION; OR

(II) FAILS TO ATTEND AT LEAST 50% OF THE REGULARLY SCHEDULED MEETINGS OF THE BOARD DURING ANY 12-MONTH PERIOD.

2 **(A) (1) THE BOARD SHALL ELECT THE CHAIR FROM AMONG ITS**
3 **MEMBERS.**

4 **(2) THE TERM OF THE CHAIR IS 2 YEARS.**

5 **(B) (1) THE BOARD SHALL MEET AT LEAST ONCE EACH QUARTER AT THE**
6 **TIMES AND PLACES SET BY THE BOARD.**

7 **(2) THE BOARD MAY CALL SPECIAL MEETINGS AT THE REQUEST OF:**

8 **(I) THE CHAIR;**

9 **(II) THE DIRECTOR; OR**

10 **(III) A MAJORITY OF THE MEMBERS OF THE BOARD.**

11 **(C) A MAJORITY OF THE MEMBERS THEN SERVING ON THE BOARD IS A**
12 **QUORUM.**

13 **(D) A MEMBER OF THE BOARD:**

14 **(1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE BOARD;**
15 **BUT**

16 **(2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE**
17 **STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.**

(A) THERE IS A SIGN LANGUAGE INTERPRETERS FUND.

(B) THE BOARD SHALL SET BY REGULATION REASONABLE FEES FOR THE ISSUANCE AND RENEWAL OF LICENSES AND OTHER SERVICES.

(C) THE BOARD SHALL PUBLISH IN ITS RULES AND REGULATIONS THE FEE SCHEDULE SET BY THE BOARD.

(D) (1) THE BOARD SHALL PAY ALL FEES COLLECTED UNDER THIS PART TO THE COMPTROLLER.

(2) THE COMPTROLLER SHALL DISTRIBUTE THE FEES TO THE FUND.

(E) THE FUND SHALL BE USED EXCLUSIVELY TO COVER THE ACTUAL DOCUMENTED DIRECT AND INDIRECT COSTS OF FULFILLING THE STATUTORY AND REGULATORY DUTIES OF THE BOARD AS PROVIDED BY THE PROVISIONS OF THIS PART, INCLUDING:

(1) THE DEVELOPMENT OF PROGRAMS THAT WILL ASSIST IN THE LICENSURE OF MARGINALIZED INTERPRETERS, INCLUDING:

(I) BLACK, INDIGENOUS, OR PERSONS OF COLOR (BIPOC) SIGNERS;

(II) HERITAGE SIGNERS; AND

(III) DEAF INDIVIDUALS;

(2) THE DEVELOPMENT OF MENTORSHIP PROGRAMS FOR INDIVIDUALS WHO PROVIDE SIGN LANGUAGE INTERPRETATION SERVICES; AND

(3) APPLICANTS EXPERIENCING FINANCIAL HARDSHIP IN THE PAYMENT OF LICENSING FEES.

(F) THE DIRECTOR SHALL ADMINISTER THE FUND.

(G) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT

1 **SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.**

2 **(2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY,**
3 **AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.**

4 **(H) THE FUND CONSISTS OF:**

5 **(1) REVENUE DISTRIBUTED TO THE FUND UNDER SUBSECTION (B) OF**
6 **THIS SECTION;**

7 **(2) MONEY APPROPRIATED IN THE STATE BUDGET FOR THE FUND;**
8 **AND**

9 **(3) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR**
10 **THE BENEFIT OF THE FUND.**

11 **(I) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE FUND**
12 **IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.**

13 **(2) ANY INVESTMENT EARNINGS OF THE FUND SHALL BE CREDITED**
14 **TO THE GENERAL FUND OF THE STATE.**

15 **(J) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE**
16 **WITH THE STATE BUDGET.**

18 **THE BOARD EXERCISES ITS POWERS, DUTIES, AND FUNCTIONS SUBJECT TO**
