A BILL ENTITLED

1 AN ACT concerning

2 **Harford County – Alcoholic Beverages – Performing Arts Nonprofit**
3 **Organization License – Record–Keeping Requirements**

4 FOR the purpose of repealing certain incorrect references to the Comptroller of Maryland
5 in certain provisions of law requiring the holder of a performing arts nonprofit
6 organization license in Harford County to comply with certain record–keeping and
7 reporting requirements; repealing the authority of the Comptroller to suspend the
8 license of a license holder without a hearing under certain circumstances;
9 authorizing, rather than requiring, the Board to summon a license holder for a
10 hearing and impose a fine under certain circumstances; and generally relating to
11 alcoholic beverages licenses in Harford County.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
23 That the Laws of Maryland read as follows:

24 **Article – Alcoholic Beverages and Cannabis**

25 22–102.

3 (b) There is a performing arts nonprofit organization beer, wine, and liquor
4 license.

5 (k) (1) The license holder shall:

6 (i) keep complete and accurate records of all alcoholic beverages
7 sold, served, and purchased under this section;

8 (ii) on written request of [the Comptroller,] the Board[,], or the
9 Executive Director, report on the form that [the Comptroller,] the Board[,], or the Executive
10 Director requires information relating to the alcoholic beverages that are the subject of the
11 records required to be kept; and

12 (iii) on request of [the Comptroller,] the Board[,], or the Executive
13 Director, make the report under oath.

14 (2) (i) Except as provided in subparagraph (ii) of this paragraph, each
15 license holder shall keep records at the location designated in the license.

16 (ii) If the license holder is allowed to have more than one location,
17 the license holder may keep the records at the principal location.

18 (iii) The records shall:

19 1. meet form and content requirements of [the Comptroller,]
20 the Board[,], or the Executive Director;

21 2. be preserved for at least 2 years in a manner that ensures
22 permanency; and

23 3. be made available for audit or inspection during regular
24 business hours by [the Comptroller,] the Board, [or] the Executive Director, or a designee
25 of [the Comptroller,] the Board[,], or the Executive Director.

26 (3) (i) [The Comptroller may without a hearing immediately suspend
27 for a maximum of 30 days the license of a license holder who fails to comply with this
28 subsection.

29 (ii) If a report required by this section or an investigation by the
30 Board, a Board officer, [the Comptroller,] the Executive Director, or any other person
31 indicates that the license holder is violating this section, the Board [shall] MAY summon
32 the license holder and conduct a hearing.

1 [(iii)] (II) If the charges at the hearing are sustained, the Board:

2 1. [shall] MAY impose a fine of not less than \$250 and not
3 more than \$2,000; and

4 2. may suspend or revoke the license holder's license
5 immediately.

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
7 1, 2025.
