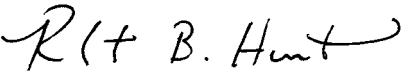

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 22 MRSA §5114, sub-§2, ¶G**, as amended by PL 2015, c. 332, §1, is further
3 amended to read:

4 G. Any other services necessary for the general well-being of older persons; or

5 **Sec. 2. 22 MRSA §5114, sub-§2, ¶H**, as enacted by PL 2015, c. 332, §2, is
6 amended to read:

7 H. Services designed to assist older persons with maintaining their financial
8 independence and avoiding financial exploitation, including personal financial
9 management assistance; or

10 **Sec. 3. 22 MRSA §5114, sub-§2, ¶I** is enacted to read:

11 I. Case management and navigation services in accordance with the federal 1987 Older
12 Americans Act, 42 United States Code, as amended.

13 **Sec. 4. Appropriations and allocations.** The following appropriations and
14 allocations are made.

15 **HEALTH AND HUMAN SERVICES, DEPARTMENT OF**

16 **Office of Aging and Disability Services Central Office 0140**

17 Initiative: Provides one-time funding to develop interventions and deliver navigation and
18 case management services for older adults in each of Maine's coordinated community
19 program areas. This appropriation must be equally distributed to each area agency to
20 develop a consistent and common infrastructure capacity statewide, including
21 standardizing services and person-centered planning and coordinated data sharing and
22 training.

31 formula to cover the cost of maintaining the services to older adults in each coordinated
32 community program area.
