A BILL

To prohibit the imposition of duties on certain baby clothing items pursuant to the International Emergency Economic Powers Act, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Baby Clothing Tax
- 5 Relief Act".

| 24 | (1) Baby garments and clothing accessories. |
| 25 | (2) Baby socks and booties. |
| 26 | (3) Baby shoes. |

- 2 (5) Baby pants and trousers.
- 3 (6) Baby swimsuits.
- 4 (7) Baby sweaters.
- 5 (8) Baby dresses.
- 6 (9) Baby onesies and bodysuits.
- 7 (10) Baby hats.
