A BILL

1	SECTION 1. BRIEFINGS ON COUNTERINTELLIGENCE AC-						
2	TIVITIES OF THE FEDERAL BUREAU OF IN-						
3	VESTIGATION.						
4	(a) In General.—Title V of section 501 of the Na-						
5	tional Security Act of 1947 (50 U.S.C. 3091 et seq.) is						
6	amended by adding at the end the following new section:						
7	"SEC. 512. BRIEFINGS ON COUNTERINTELLIGENCE ACTIVI-						
8	TIES OF THE FEDERAL BUREAU OF INVES-						
9	TIGATION.						
10	"(a) Quarterly Briefings.—Not less frequently						
11	than once each quarter, the Director of the Federal Bu-						
12	reau of Investigation shall provide to the congressional in-						
13	telligence committees a briefing on the counterintelligence						
14	activities of the Federal Bureau of Investigation. Such						
15	briefings shall include, at a minimum, an overview and up-						
16	date of—						
17	"(1) the counterintelligence posture of the Bu-						
18	reau;						
19	"(2) counterintelligence investigations; and						
20	"(3) any other information relating to the coun-						
21	terintelligence activities of the Bureau that the Di-						
22	rector determines necessary.						
23	"(b) Notifications.—In addition to the quarterly						
24	briefings under subsection (a), the Director of the Federal						
25	Bureau of Investigation shall promptly notify the congres-						
26	sional intelligence committees of any counterintelligence						

1	investigation	carried	out	by	the	Bureau	regarding	any	of

- 3 "(1) A candidate who seeks nomination for elec-
- 4 tion, or election, to a Federal office.
- 5 "(2) A political campaign of a candidate who
- 6 seeks nomination for election, or election, to a Fed-
- 7 eral office.
- 8 "(3) An individual known to be associated with
- 9 a political campaign of a candidate who seeks nomi-
- nation for election, or election, to a Federal office.
- 11 "(c) Guidelines.—The Director, in coordination
- 12 with the Attorney General and in consultation with the
- 13 congressional intelligence committees, shall develop guide-
- 14 lines governing the scope of the briefings provided under
- 15 subsection (a) and the notifications under subsection
- 16 (b).".
- 17 (b) Clerical Amendment.—The table of contents
- 18 at the beginning of such Act is amended by inserting after
- 19 the item relating to section 511 the following new item:

"Sec. 512. Briefings on counterintelligence activities of the Federal Bureau of Investigation.".
