Shelter Services for Homeless Women - Feminine Hygiene Products

- FOR the purpose of requiring the Department of Human Resources to make available to local administering agencies for certain service providers and to certain service providers a certain supply of feminine hygiene products for a certain purpose; providing that certain feminine hygiene products be made available to certain entities and to female residents in shelters for free; defining certain terms; and generally relating to feminine hygiene products and shelter services for homeless women.

- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND.

- 21 PART V. HOMELESS WOMEN FEMININE HYGIENE PRODUCTS.

- IN THIS PART THE FOLLOWING WORDS HAVE THE MEANINGS 1 (A) **(1)** 2 INDICATED.
- 3 "FEMININE HYGIENE PRODUCTS" **MEANS (2) TAMPONS** AND SANITARY NAPKINS FOR USE IN CONNECTION WITH THE MENSTRUAL CYCLE. 4
- 5 **(3)** "LOCAL ADMINISTERING AGENCY" MEANS THE DESIGNATED BY THE DEPARTMENT OR A LOCAL GOVERNMENT TO MANAGE THE 6 7 PROGRAMS FOR TRANSITIONAL HOUSING SERVICES, INCLUDING THE HOMELESS
- WOMEN CRISIS SHELTER HOME PROGRAM, AND TO PROVIDE A SERVICE 8
- DIRECTLY OR BY CONTRACT WITH A SERVICE PROVIDER. 9
- 10 "SERVICE PROVIDER" MEANS A PUBLIC OR PRIVATE NONPROFIT **(4)** THAT CONTRACTS WITH THE DEPARTMENT OR A LOCAL ADMINISTERING AGENCY TO 11 12 PROVIDE SHELTER SERVICES FOR HOMELESS INDIVIDUALS.
- 13 (B) **(1)** THE DEPARTMENT SHALL MAKE AVAILABLE TO LOCAL 14 ADMINISTERING AGENCIES FOR SERVICE PROVIDERS AND TO SERVICE PROVIDERS A SUPPLY OF FEMININE HYGIENE PRODUCTS SUFFICIENT TO MEET THE NEEDS OF 15 FEMALE RESIDENTS IN SHELTERS. 16
- 17 **(2)** THE **FEMININE HYGIENE PRODUCTS PROVIDED** UNDER PARAGRAPH (1) OF THIS SUBSECTION SHALL BE MADE AVAILABLE TO LOCAL 18 19 ADMINISTERING AGENCIES FOR SERVICE PROVIDERS, TO SERVICE PROVIDERS, AND 20 TO FEMALE RESIDENTS IN SHELTERS FOR FREE.
- 21SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 22October 1, 2017.
