A BILL

To amend title 18, United States Code, to include doping fraud as a predicate offense for racketeering and money laundering offenses, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Guarantee Oversight
- 5 and Litigation on Doping Act" or the "GOLD Act".
- 6 SEC. 2. SENSE OF CONGRESS.
- 7 It is the sense of Congress that—
- 8 (1) the punishment of Russia for persistent dec-
- 9 ades-long state-run doping fraud by the inter-

21	following: ", or section 3 of the Rodchenkov
22	Anti-Doping Act of 2019 (21 U.S.C. 2402) (re-
23	lating to prohibited activities with respect to
24	major international doping fraud conspiracies)";

2	(A) by striking "or (G) any act" and in-
3	serting "(G) any act"; and
4	(B) by inserting after "section
5	2332(b)(g)(5)(B)" the following: ", or (H) any
6	act that is indictable under section 3 of the
7	Rodchenkov Anti-Doping Act of 2019 (21
8	U.S.C. 2402)".
