6 7	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

10 11	(a) (1) Except as provided in paragraph (2) of this subsection, each applicant for a senatorial scholarship shall:
12	(i) Take a competitive examination administered by the Office; and
13 14 15 16	(ii) Be accepted for admission in the regular undergraduate, graduate, or professional program at an eligible institution; or be enrolled in a 2-year terminal certificate program in which the course work is acceptable for transfer credit for an accredited baccalaureate program in an eligible institution.
17	(2) An applicant is exempt from the examination if the applicant:
18 19	(i) Is attending an eligible institution and has completed at least 1 year in good academic standing at the institution;
20 21	(ii) Graduated from high school at least 5 years before application for a senatorial scholarship;
22 23 24 25	(iii) Is accepted for admission to a private career institution, if the institution's curriculum is approved by the Commission, and the institution is accredited by a national accrediting association approved by the United States Department of Education; or

A recipient of an undergraduate or graduate senatorial scholarship may hold

the scholarship, appropriately prorated, for 8 academic years if [he] THE RECIPIENT:
