A BILL

To reauthorize the Rivers of Steel National Heritage Area, the Lackawanna Valley National Heritage Area, the Delaware and Lehigh National Heritage Corridor, the Schuylkill River Valley National Heritage Area, and the Oil Region National Heritage Area, and for other purposes.

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Pennsylvania National
5 Heritage Areas Reauthorization Act”.

1 **SEC. 2. REAUTHORIZATION OF, AND REPEAL OF FUNDING**
2 **LIMITATIONS FOR, NATIONAL HERITAGE**
3 **AREAS AND CORRIDOR.**

4 (a) RIVERS OF STEEL NATIONAL HERITAGE
5 AREA.—

12 (2) REPEAL OF FUNDING LIMITATION.—Section
13 409(a) of the Steel Industry American Heritage
14 Area Act of 1996 (54 U.S.C. 320101 note; Public
15 Law 104–333; 110 Stat. 4256; 129 Stat. 2551; 133
16 Stat. 778) is amended by striking the second sen-
17 tence.

18 (b) LACKAWANNA VALLEY NATIONAL HERITAGE
19 AREA.—

1 (2) REPEAL OF FUNDING LIMITATION.—Section

 4 Law 106–278; 114 Stat. 818) is amended by strik-
 5 ing subsection (a) and inserting the following:

 7 priated to carry out this title \$1,000,000 for each fiscal
 8 year.”.

 9 priated to carry out this title \$1,000,000 for each fiscal
 10 year.”.

11 (e) OIL REGION NATIONAL HERITAGE AREA.—

 13 Region National Heritage Area Act (54 U.S.C.
 14 320101 note; Public Law 108–447; 118 Stat. 3372;
 15 133 Stat. 2713) is amended by striking “September
 16 30, 2022” and inserting “September 30, 2036”.

17 (2) REPEAL OF FUNDING LIMITATION.—Section
 18 612 of the Oil Region National Heritage Area Act
 19 (54 U.S.C. 320101 note; Public Law 108–447; 118
 20 Stat. 3373) is amended by striking subsection (a)
 21 and inserting the following:

22 “(a) IN GENERAL.—There is authorized to be appro-
 23 priated to carry out this title \$1,000,000 for each fiscal
 24 year.”.
