A BILL

To amend title 38, United States Code, to extend and expand the membership of the Advisory Committee on Minority Veterans to include veterans who are lesbian, gay, bisexual, or transgender.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Voices for Veterans
 5 Act”.

6 **SEC. 2. EXTENSION AND EXPANSION OF MEMBERSHIP OF**
 7 **THE ADVISORY COMMITTEE ON MINORITY**
 8 **VETERANS TO INCLUDE VETERANS WHO ARE**
 9 **LESBIAN, GAY, BISEXUAL OR TRANSGENDER.**

10 (a) EXPANSION OF MEMBERSHIP.—Subsection
 11 (a)(2)(A) of section 544 of title 38, United States Code,
 12 is amended—

13 (1) in clause (iv), by striking “and” at the end;

14 (2) in clause (v), by striking the period at the
 15 end and inserting “; and”; and

16 (3) by inserting after clause (v) the following
 17 new clauses:

18 “(vi) veterans who are lesbian, gay, bisexual, or
 19 transgender.”.

20 (b) EXTENSION.—Subsection (e) of such section is
 21 amended by striking “December 31, 2017” and inserting
 22 “December 31, 2019”.

23 (c) EFFECTIVE DATE.—Clause (vi) of section
 24 544(a)(2)(A) of title 38, United States Code, shall apply

1 to appointments made on or after the date of the enact-
2 ment of this Act.
