WHEREAS, it is with highest commendation that we recognize Sergeant Larry Toland, Officer Zackary Davis, and Corporal Pat Sanders of the Mobile Police Department and Officer Clarence Adams of the Prichard Police Department as nominees for the 2017 Alabama Legislative Medal of Honor for Law Enforcement, Alabama's highest law enforcement award for extraordinary courage in the line of duty; and

WHEREAS, during the early morning hours of April 1, 2016, Sergeant Larry Toland, Officer Zackary Davis, Corporal Pat Sanders, and Officer Clarence Adams, members of the Mobile County Street Enforcement Narcotics Team, led the undercover operation designed to apprehend "Rider," the self-proclaimed leader of a compound located in a rural area of Mobile County that was used as a drug distribution hub for other illegal

activities; upon his arrival at the location of the sting, Rider attempted to flee from the officers; Officer Davis caught up with him and Sergeant Toland and Officer Adams arrived seconds later; Rider continued to fight with the three officers and fired a Glock pisol, striking Officer Davis in the abdomen; with Officer Davis now incapacitated, Rider fired from less than five feet away at Sergeant Toland, Officer Adams, and Corporal Sanders who had arrived on the scene; Sergeant Toland, Officer Adams, and Corporal Sanders returned fire and incapacitated the suspect despite the fact that he was wearing a military style Kevlar vest and a motorcycle helmet; Sergeant Toland, Officer Adams, and Corporal Sanders secured the wounded assailant and carried gravely wounded Officer Davis to a Mobile County Sheriff's Department patrol car that had stopped to investigate; Officer Davis was transported to the hospital; and
