Pollinator Habitat Plans – Plan Contents – Requirement Requirements and Prohibition

- 4 FOR the purpose of requiring a certain pollinator habitat plan to include certain best management practices for the designation of certain habitat areas; requiring that a 5 certain pollinator habitat plan established by the Department of Natural Resources, 6 7 the Maryland Environmental Service, and the State Highway Administration be as 8 protective of pollinators as the Department of Agriculture's managed pollinator 9 protection plan; prohibiting the use of certain pesticides, seeds, or plants in the 10 pollinator habitat plan a certain pollinator habitat area, subject to certain exceptions; defining a certain term; making conforming changes; and generally 11 relating to pollinator habitat plans. 12
