A BILL ENTITLED

1 AN ACT concerning

2 **Environment – On-Site Wastewater Services – Regulation**

3 FOR the purpose of establishing the State Board of On-Site Wastewater Professionals in
4 the Department of the Environment; specifying the purpose and composition of the
5 Board; specifying the term of a Board member; providing for the appointment of
6 Board members; authorizing the Governor to remove a member of the Board under
7 certain circumstances; requiring the Board to designate the chair of the Board;
8 requiring the Board to make certain determinations relating to its officers; specifying
9 that a majority of the members then serving on the Board is a quorum; requiring the
10 Board to determine the times and places of its meetings; specifying that a Board
11 member is entitled to certain reimbursement; authorizing the Board to employ staff
12 in accordance with the State budget; requiring the Board to make recommendations
13 to the Department on the adoption of regulations to carry out the provisions of this
14 Act; requiring the Board to review certain regulations; specifying the duties of the
15 Board; requiring a county to enforce and adopt certain standards relating to certain
16 design, installation, and maintenance of certain on-site wastewater systems;
17 requiring the Board to set reasonable fees for a certain purpose; requiring the Board
18 to publish a schedule of the fees; requiring the Board to pay certain funds collected
19 from certain fees into the On-Site Wastewater Professionals Fund; establishing the
20 Fund as a special, nonlapsing fund; specifying the purpose of the Fund; requiring the
21 Board to administer the Fund; requiring the State Treasurer to hold the Fund, and
22 the Comptroller to account for the Fund; specifying the contents of the Fund;
23 specifying the purpose for which the Fund may be used; requiring interest earnings
24 of the Fund to be credited to the Fund; providing for expenditures from the Fund;
25 requiring the Board to submit a certain annual report to the Secretary of the
26 Environment; requiring a certain individual to be licensed by the Board before
27 performing certain on-site wastewater services in the State; requiring an applicant
28 for a license to meet certain requirements established by regulation and to submit a
29 certain application and pay a certain fee to the Board; requiring that a business
30 performing on-site wastewater services or contracting to perform certain on-site
31 wastewater services have an employee or owner licensed by the Board; authorizing

the Board to take certain disciplinary action against an applicant or a licensee under certain circumstances; requiring the Board to give a certain individual an opportunity for a hearing before the Board and to give certain notice and hold the hearing in accordance with certain provisions of law; authorizing the Board to administer oaths under certain circumstances; authorizing the Board to hear and determine a matter under certain circumstances; authorizing a person aggrieved by a decision of the Board to take certain action under certain circumstances; prohibiting a person from performing certain on-site wastewater services without a license from the Board; prohibiting the borrowing, renting, or transferring of a license; establishing a certain penalty for violations of this Act; requiring that the failure to pay a certain penalty be forwarded to the Central Collection Unit under certain circumstances; exempting the Fund from a certain provision of law requiring interest earnings on State money to accrue to the General Fund of the State; defining certain terms; providing for the application of this Act; specifying that this Act does not prevent or prohibit a local government from imposing certain requirements or standards; requiring that the Board be fully operational on or before a certain date; specifying the terms of the initial members of the Board; and generally relating to the establishment of the State Board of On-Site Wastewater Professionals and the regulation of individuals performing on-site wastewater services in the State.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

That the Laws of Maryland read as follows:

7 **(B) “BOARD” MEANS THE STATE BOARD OF ON-SITE WASTEWATER**

9 **(C) “LICENSE” MEANS ANY CATEGORY OF PROFESSIONAL LICENSE OR**
10 **CERTIFICATION ISSUED BY THE BOARD TO AN INDIVIDUAL TO PERFORM ON-SITE**
11 **WASTEWATER SERVICES IN THE STATE.**

12 **(D) “ON-SITE WASTEWATER SERVICES” MEANS ANY ACTIVITY ASSOCIATED**
13 **WITH THE DESIGN, INSTALLATION, OPERATION AND MAINTENANCE, PUMPING,**
14 **REPAIR, OR PROPERTY TRANSFER INSPECTION OF AN ON-SITE WASTEWATER**
15 **SYSTEM.**

16 **(E) (1) “ON-SITE WASTEWATER SYSTEM” MEANS:**

17 **(I) A WASTEWATER SYSTEM DESIGNED TO TREAT AND DISPOSE**
18 **OF EFFLUENT ON THE SAME PROPERTY THAT PRODUCES THE WASTEWATER; OR**

19 **(II) A HOLDING TANK.**

20 **(2) “ON-SITE WASTEWATER SYSTEM” INCLUDES A SEPTIC OR ANY**
21 **OTHER ON-SITE SEWAGE DISPOSAL SYSTEM.**

5 **(A) THERE IS A STATE BOARD OF ON-SITE WASTEWATER PROFESSIONALS**
6 **IN THE DEPARTMENT.**

7 **(B) THE PURPOSE OF THE BOARD IS TO:**

8 **(1) REGULATE INDIVIDUALS WHO PERFORM ON-SITE WASTEWATER**
9 **SERVICES IN THE STATE; AND**

10 **(2) ESTABLISH, IN CONSULTATION WITH THE DEPARTMENT,**
11 **MINIMUM STANDARDS FOR ON-SITE WASTEWATER SYSTEMS THAT ARE NOT**
12 **REQUIRED TO BE PERMITTED UNDER § 9-323 OF THIS TITLE, INCLUDING**
13 **STANDARDS FOR THE PROCESSES, PROCEDURES, TECHNIQUES, AND MATERIALS**
14 **ASSOCIATED WITH THE PROPER DESIGN, ACCEPTABLE INSTALLATION, ADEQUATE**
15 **OPERATION AND MAINTENANCE, INCLUDING PUMPING OR REPAIR, AND PROPERTY**
16 **TRANSFER INSPECTION OF AN ON-SITE WASTEWATER SYSTEM.**

21 **(II) ONE REPRESENTATIVE OF THE DEPARTMENT, DESIGNATED**
22 **BY THE SECRETARY;**

23 **(III) ONE REPRESENTATIVE OF THE MARYLAND CONFERENCE**
24 **OF LOCAL ENVIRONMENTAL HEALTH DIRECTORS, DESIGNATED BY THE MARYLAND**
25 **CONFERENCE OF LOCAL ENVIRONMENTAL HEALTH DIRECTORS; AND**

26 **(IV) ONE INDIVIDUAL DESIGNATED BY THE MARYLAND ONSITE**
27 **WASTEWATER PROFESSIONALS ASSOCIATION.**

28 **(2) OF THE MEMBERS OF THE BOARD:**

1 **(I) SEVEN SHALL BE ON-SITE WASTEWATER PROFESSIONALS**
2 **CURRENTLY LICENSED OR CERTIFIED BY THE STATE OR A LOCAL GOVERNMENT;**
3 **AND**

4 **(II) TWO SHALL BE CONSUMER MEMBERS.**

5 **(3) (I) 1. SUBJECT TO SUBSUBPARAGRAPH 2 OF THIS**
6 **SUBPARAGRAPH AND SUBPARAGRAPH (II) OF THIS PARAGRAPH, OF THE SEVEN**
7 **ON-SITE WASTEWATER PROFESSIONAL MEMBERS OF THE BOARD:**

8 **A. AT LEAST ONE SHALL BE A LICENSED MASTER**
9 **INSTALLER;**

10 **B. AT LEAST ONE SHALL BE A LICENSED MASTER**
11 **PUMPER;**

12 **C. AT LEAST ONE SHALL BE A LICENSED MASTER**
13 **OPERATIONS AND MAINTENANCE PROVIDER;**

14 **D. AT LEAST ONE SHALL BE A CERTIFIED DESIGNER; AND**

15 **E. AT LEAST ONE SHALL BE A LICENSED MASTER**
16 **PROPERTY TRANSFER INSPECTOR.**

17 **2. A SINGLE BOARD MEMBER MAY SATISFY UP TO TWO**
18 **OF THE PROFESSIONAL LICENSE AND CERTIFICATION MEMBERSHIP**
19 **REQUIREMENTS SPECIFIED UNDER SUBSUBPARAGRAPH 1 OF THIS SUBPARAGRAPH.**

20 **(II) OF THE SEVEN ON-SITE WASTEWATER PROFESSIONAL**
21 **MEMBERS OF THE BOARD:**

22 **1. AT LEAST ONE SHALL BE FROM THE AREA THAT**
23 **CONSISTS OF ALLEGANY COUNTY, FREDERICK COUNTY, GARRETT COUNTY, AND**
24 **WASHINGTON COUNTY;**

25 **2. AT LEAST ONE SHALL BE FROM THE AREA THAT**
26 **CONSISTS OF BALTIMORE CITY, BALTIMORE COUNTY, CARROLL COUNTY,**
27 **HARFORD COUNTY, HOWARD COUNTY, AND MONTGOMERY COUNTY;**

28 **3. AT LEAST ONE SHALL BE FROM THE AREA THAT**
29 **CONSISTS OF ANNE ARUNDEL COUNTY, CALVERT COUNTY, CHARLES COUNTY,**
30 **PRINCE GEORGE'S COUNTY, AND ST. MARY'S COUNTY; AND**

1 4. AT LEAST ONE SHALL BE FROM THE AREA THAT
2 CONSISTS OF CAROLINE COUNTY, CECIL COUNTY, DORCHESTER COUNTY, KENT
3 COUNTY, QUEEN ANNE'S COUNTY, SOMERSET COUNTY, TALBOT COUNTY,
4 WICOMICO COUNTY, AND WORCESTER COUNTY.

5 (4) ON OR BEFORE JULY 1, 2023, ALL ON-SITE WASTEWATER
6 PROFESSIONAL MEMBERS OF THE BOARD SHALL HOLD A LICENSE.

7 (5) EACH CONSUMER MEMBER OF THE BOARD:

8 (I) SHALL BE A MEMBER OF THE GENERAL PUBLIC;

9 (II) MAY NOT BE A LICENSEE OR OTHERWISE BE SUBJECT TO
10 REGULATION BY THE BOARD;

11 (III) MAY NOT BE REQUIRED TO MEET THE QUALIFICATIONS FOR
12 THE PROFESSIONAL MEMBERS OF THE BOARD; AND

13 (IV) MAY NOT, WITHIN 1 YEAR BEFORE APPOINTMENT, HAVE
14 HAD A FINANCIAL INTEREST IN OR HAVE RECEIVED COMPENSATION FROM A PERSON
15 REGULATED BY THE BOARD.

16 (B) WHILE A MEMBER OF THE BOARD, A CONSUMER MEMBER MAY NOT:

17 (1) HAVE A FINANCIAL INTEREST IN OR RECEIVE COMPENSATION
18 FROM A PERSON REGULATED BY THE BOARD; OR

19 (2) GRADE AN EXAMINATION GIVEN BY OR FOR THE BOARD.

20 (C) BEFORE TAKING OFFICE, EACH APPOINTEE TO THE BOARD SHALL TAKE
21 THE OATH REQUIRED BY ARTICLE I, § 9 OF THE MARYLAND CONSTITUTION.

22 (D) (1) THE TERM OF A MEMBER IS 3 YEARS.

23 (2) A MEMBER MAY SERVE TWO TERMS CONSECUTIVELY.

24 (3) THE TERMS OF MEMBERS ARE STAGGERED AS REQUIRED BY THE
25 TERMS PROVIDED FOR MEMBERS OF THE BOARD ON JULY 1, 2020.

26 (4) AT THE END OF A TERM, A MEMBER CONTINUES TO SERVE UNTIL
27 A SUCCESSOR IS APPOINTED AND QUALIFIES.

1 **(5) A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN SERVES**
2 **ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED AND**
3 **QUALIFIES.**

4 **(E) THE GOVERNOR MAY REMOVE A MEMBER FOR INCOMPETENCE OR**
5 **MISCONDUCT.**

7 **(A) THE MEMBERS OF THE BOARD SHALL DESIGNATE A CHAIR.**

8 **(B) THE BOARD SHALL DETERMINE THE MEANS OF THE ELECTION OF**

(B) THE BOARD SHALL:

(1) CARRY OUT THE PROVISIONS OF THIS SUBTITLE;

(2) ON OR BEFORE JUNE 1, 2024, MAKE RECOMMENDATIONS TO THE DEPARTMENT FOR ESTABLISHING THE LICENSING AND CERTIFICATION PROCEDURES SPECIFIED UNDER SUBSECTION (A)(1) OF THIS SECTION;

(3) COLLECT AND ACCOUNT FOR THE FEES PROVIDED FOR UNDER THIS SUBTITLE; AND

(4) KEEP A CURRENT RECORD OF ALL INDIVIDUALS AND ENTITIES LICENSED UNDER THIS SUBTITLE.

A COUNTY SHALL:

9 (B) THERE IS AN ON-SITE WASTEWATER PROFESSIONALS FUND.

10 (C) THE PURPOSE OF THE FUND IS TO PROVIDE FUNDING TO MAINTAIN THE
11 BOARD.

12 (D) THE BOARD SHALL ADMINISTER THE FUND.

13 (E) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT
14 SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

15 (2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY,

21 (3) INTEREST EARNINGS OF THE FUND;

22 (4) DONATIONS TO THE FUND; AND

23 (5) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR
24 THE BENEFIT OF THE FUND.

25 (G) THE FUND SHALL BE USED ONLY TO MAINTAIN THE BOARD AND
26 IMPLEMENT THE PROVISIONS OF THIS SUBTITLE.

1 **(H) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE FUND**
2 **IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.**

3 **(2) ANY INTEREST EARNINGS OF THE FUND SHALL BE CREDITED TO**
4 **THE FUND.**

5 **(I) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE**
6 **WITH THE STATE BUDGET.**

7 **(J) MONEY EXPENDED FROM THE FUND TO MAINTAIN THE BOARD OR**
8 **IMPLEMENT THE PROVISIONS OF THIS SUBTITLE IS SUPPLEMENTAL TO AND IS NOT**
9 **INTENDED TO TAKE THE PLACE OF FUNDING THAT OTHERWISE WOULD BE**
10 **APPROPRIATED FOR THE BOARD.**
