### AN ACT

Making emergency supplemental appropriations to address the shortage of infant formula in the United States for the fiscal year ending September 30, 2022, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That the following sums are appropriated, out of any
- 4 money in the Treasury not otherwise appropriated, for the
- 5 fiscal year ending September 30, 2022, and for other pur-
- 6 poses, namely:

1	RELATED AGENCIES AND FOOD AND DRUG
2	ADMINISTRATION
3	DEPARTMENT OF HEALTH AND HUMAN SERVICES
4	FOOD AND DRUG ADMINISTRATION
5	SALARIES AND EXPENSES
6	For an additional amount for "Salaries and Ex-
7	penses", \$28,000,000, to remain available until September
8	30, 2023, shall be available to address the current short-
9	age of FDA-regulated infant formula and certain medical
10	foods in the United States and to prevent future short-
11	ages, including such steps as may be necessary to prevent
12	fraudulent products from entering the United States mar-
13	ket: Provided, That the Commissioner of Food and Drugs
14	shall report to the Committees on Appropriations of the
15	House of Representatives and the Senate on a weekly
16	basis on obligations of funding under this heading in this
17	Act to address the shortage of infant formula and certain
18	medical foods in the United States: Provided further, That
19	such amount is designated by the Congress as being for
20	an emergency requirement pursuant to section 4001(a)(1)
21	and section 4001(b) of S. Con. Res. 14 (117th Congress),
22	the concurrent resolution on the budget for fiscal year
23	2022.

### 1 GENERAL PROVISIONS—THIS ACT

- 2 Sec. 101. Each amount appropriated or made avail-
- 3 able by this Act is in addition to amounts otherwise appro-
- 4 priated for the fiscal year involved.
- 5 Sec. 102. Unless otherwise provided for by this Act,
- 6 the additional amounts appropriated by this Act to appro-
- 7 priations accounts shall be available under the authorities
- 8 and conditions applicable to such appropriations accounts
- 9 for fiscal year 2022.
- This Act may be cited as the "Infant Formula Sup-
- 11 plemental Appropriations Act, 2022".
