	Section 1. Section 26-6-33 is enacted to read:
	26-6-33. Department support for local education agency test to stay programs
Dep	partment guidance for local education agencies.
	(1) As used in this section:
	(a) "Case threshold" means the same as that term is defined in Section 53G-9-210.
	(b) "COVID-19" means the same as that term is defined in Section 53G-9-210.
	(c) "Local education agency" or "LEA" means the same as that term is defined in
Sec	tion 53G-9-210.
	(d) "Test to stay program" means the same as that term is defined in Section
<u>53C</u>	<u>5-9-210.</u>
	(2) In coordination with the State Board of Education, and at the request of an LEA,
the	department shall provide support for the LEA's test to stay program if a school in the LEA
reac	ches the case threshold, including by providing:
	(a) COVID-19 testing supplies;
	(b) a mobile testing unit; and
	(c) other support requested by the LEA related to the LEA's test to stay program.
	(3) The department shall ensure that guidance the department provides to LEAs related
to to	est to stay programs complies with Section 53G-9-210, including the determination of
whe	ether a school meets a case threshold described in Subsection 53G-9-210(3).
	Section 2. Section <b>53G-9-210</b> is enacted to read:
	53G-9-210. Test to stay programs.
	(1) As used in this section:
	(a) "Case threshold" means as applicable, the number of students in a school, or
per	centage of students in a school who meet the conditions described in Subsection (3).
	(b) "COVID-19" means:

57	(i) severe acute respiratory syndrome coronavirus 2; or
58	(ii) the disease caused by severe acute respiratory syndrome coronavirus 2.
59	(c) "Local Education Agency" or LEA means:
60	(i) a school district;
61	(ii) a charter school, other than an online-only charter school; or
62	(iii) the Utah Schools for the Deaf and the Blind.
63	(d) "Test to stay program" means a program through which an LEA provides testing for
64	COVID-19 for students during an outbreak of COVID-19 at a school in order to:
65	(i) identify cases of COVID-19; and
66	(ii) allow individuals who test negative for COVID-19 to attend school in person.
67	(2) An LEA may allow a school that reaches the case threshold to continue to offer
68	in-person instruction if the school initiates a test to stay program for the school.
69	(3) (a) For purposes of determining whether a school has reached the school's case
70	threshold, a student is included in positive cases for the school if the student:
71	(i) tested positive for COVID-19 within the past 14 days;
72	(ii) contracted COVID-19 at school; and
73	(iii) did not receive the student's positive COVID-19 test results through regular
74	periodic testing required to participate in LEA-sponsored athletics or another LEA-sponsored
75	extracurricular activity.
76	(b) (i) A school with 1,500 or more students meets the case threshold if at least 2% of
77	the school's students meet the conditions described in Subsection (3)(a).
78	(ii) A school with fewer than 1,500 students meets the case threshold if 30 or more of
79	the school's students meet the conditions described in Subsection (3)(a).
80	(4) An LEA may seek advance consent from a student's parent for future testing for
81	COVID-19.
82	Section 3. Effective date.
83	If approved by two-thirds of all the members elected to each house, this bill takes effect
84	upon approval by the governor, or the day following the constitutional time limit of Utah
85	Constitution, Article VII, Section 8, without the governor's signature, or in the case of a veto,
86	the date of veto override.
