SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That Section(s) 9–317 of Article – Health Occupations of the Annotated Code of Maryland be renumbered to be Section(s) 9–208.

SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read as follows:

Article – Health Occupations

Title 9. Nursing Home Administrators **AND ASSISTED LIVING MANAGERS.**

9–101.

(a) In this title the following words have the meanings indicated.

(B) “ASSISTED LIVING MANAGER” MEANS AN INDIVIDUAL WHO OVERSEES AND IS RESPONSIBLE FOR THE DAY–TO–DAY OPERATION OF AN ASSISTED LIVING PROGRAM.

(C) “ASSISTED LIVING PROGRAM” HAS THE MEANING STATED IN § 19–1801 OF THE HEALTH – GENERAL ARTICLE.

[(b)] (D) “Board” means the State Board of [Examiners of Nursing Home] LONG–TERM CARE Administrators.

(E) “FAMILY MEMBER” MEANS:

(1) A SPOUSE;

(2) A CHILD;

(3) A SIBLING;

(4) A PARENT;

(5) A GRANDPARENT;

(6) A NIECE OR NEPHEW; OR

(7) AN UNCLE OR AUNT.

[(c)] (F) “License” means, unless the context requires otherwise[a]:

(1) A license issued by the Board to practice as a nursing home administrator **UNDER SUBTITLE 3 OF THIS TITLE; OR**

(2) A LICENSE ISSUED BY THE BOARD TO PRACTICE AS AN ASSISTED LIVING MANAGER UNDER SUBTITLE 3A OF THIS TITLE.

(G) “LICENSED ASSISTED LIVING MANAGER” MEANS, UNLESS THE CONTEXT REQUIRES OTHERWISE, AN INDIVIDUAL WHO IS LICENSED BY THE BOARD TO PRACTICE AS AN ASSISTED LIVING MANAGER.

[(d)] (H) “Licensed nursing home administrator” means, unless the context requires otherwise, an individual who is licensed by the Board to practice as a nursing home administrator.

[(e)] (I) “Nursing home” means an institution or part of an institution that:

(1) Is a “skilled nursing facility” or an “intermediate care facility” as those terms are defined by federal law and participates in a program under Title XVIII or Title XIX of the Social Security Act; or

(2) If it is licensed only by this State, otherwise meets the federal requirements for a “skilled nursing facility” or an “intermediate care facility” as those terms are defined by federal law.

[(f)] (J) “Nursing home administrator” means an individual who administers, manages, or is in general administrative charge of a nursing home whether or not the individual:

(1) Has an ownership interest in the nursing home; or

(2) Shares duties and functions with other individuals.

Subtitle 2. State Board of [Examiners of Nursing Home] ~~LONG-TERM CARE~~

3 (a) (1) The Board consists of ~~[14]~~ **17** members.

4 (2) Of the ~~[14]~~ Board members:

5 (i) Six shall be licensed nursing home administrators, one of whom
6 has experience with the Eden Alternative Green House or a similar program, if practicable;

7 (ii) Two shall be individuals who are not nursing home
8 administrators **OR ASSISTED LIVING MANAGERS** but who are engaged actively in
9 professions that are concerned with the care of chronically ill, infirm, or aged individuals;

10 (III) **1. BEFORE OCTOBER 1, 2024, THREE SHALL BE**
11 **ASSISTED LIVING MANAGERS WHO HAVE:**

12 **A. COMPLETED THE MANAGER TRAINING COURSE**
13 **REQUIRED UNDER § 19–1807 OF THE HEALTH – GENERAL ARTICLE; AND**

14 **B. ACTIVELY PRACTICED FOR AN ASSISTED LIVING**
15 **PROGRAM; AND**

16 **2. ON OR AFTER OCTOBER 1, 2024, THREE SHALL BE**
17 **LICENSED ASSISTED LIVING MANAGERS;**

18 ~~[(iii)]~~ **(IV)** One shall be a physician or a nurse practitioner who
19 specializes in geriatrics;

20 ~~[(iv)]~~ **(V)** One shall be a geriatric social worker;

21 ~~[(v)]~~ **(VI)** One shall be the State Long–Term Care Ombudsman
22 designated under § 10–903 of the Human Services Article; and

23 ~~[(vi)]~~ **(VII)** Two shall be consumer members.

24 (3) Not more than three members may be officials or full–time employees
25 of this State or of any of its political subdivisions.

26 (4) A representative of the Office of Health Care Quality shall serve as an
27 ex officio member.

28 (b) (1) The Governor shall appoint the consumer members with the advice of
29 the Secretary and the advice and consent of the Senate.

1 (2) (i) Except for the consumer members and the State Long-Term
2 Care Ombudsman, the Governor shall appoint each Board member, with the advice of the
3 Secretary.

4 (ii) The Secretary shall recommend a professional who:

5 1. Is actively practicing;

6 2. Has a minimum of 5 years of appropriate practice
7 experience in the discipline of the vacancy to be filled; and

8 3. Otherwise meets the requirements of this section.

9 (c) Each Board member shall:

10 (1) Be a United States citizen or have declared an intent to become a
11 United States citizen; and

12 (2) Have resided in this State for at least 1 year before appointment to the
13 Board.

14 (d) (1) Each consumer member of the Board:

15 (i) Shall be a member of the general public;

16 (ii) May not be or ever have been a nursing home administrator **OR**
17 **AN ASSISTED LIVING MANAGER** or in training to become a nursing home administrator
18 **OR AN ASSISTED LIVING MANAGER;**

19 (iii) May not have a household member who is a nursing home
20 administrator **OR AN ASSISTED LIVING MANAGER** or in training to become a nursing
21 home administrator **OR AN ASSISTED LIVING MANAGER;**

22 (iv) May not participate or ever have participated in a commercial or
23 professional field related to the practice of a nursing home administrator **OR ASSISTED**
24 **LIVING MANAGER;**

25 (v) May not have a household member who participates in a
26 commercial or professional field related to the practice of a nursing home administrator **OR**
27 **AN ASSISTED LIVING MANAGER;** and

28 (vi) May not have had within 2 years before appointment a
29 substantial financial interest in a person regulated by the Board.

30 (2) **OF THE CONSUMER MEMBERS:**

(I) One [consumer member] shall have presently or have had **WITHIN THE 5 YEARS IMMEDIATELY PRECEDING INITIAL APPOINTMENT** a family member living in a nursing home; **AND**

(II) **ONE SHALL HAVE PRESENTLY OR HAVE HAD WITHIN THE 5 YEARS IMMEDIATELY PRECEDING INITIAL APPOINTMENT A FAMILY MEMBER WHO RECEIVES SERVICES LIVING IN AN ASSISTED LIVING PROGRAM.**

(e) While a member of the Board, a consumer member may not have a substantial financial interest in a person regulated by the Board.

(f) Before taking office, each appointee to the Board shall take the oath required by Article I, § 9 of the Maryland Constitution.

(g) (1) This subsection does not apply to the State Long-Term Care Ombudsman.

(2) The term of a member is 4 years.

(3) The terms of members are staggered as required by the terms provided for members of the Board on July 1, 1981.

(4) At the end of a term, a member continues to serve until a successor is appointed and qualifies.

(5) A member who is appointed after a term has begun serves only for the rest of the term and until a successor is appointed and qualifies.

(6) A member may not serve more than 2 consecutive full terms.

(7) To the extent practicable, the Governor shall fill any vacancy on the Board within 60 days of the date of the vacancy.

(h) (1) The Governor may remove a member for incompetence, misconduct, incapacity, or neglect of duty.

(2) Upon the recommendation of the Secretary, the Governor may remove a member whom the Secretary finds to have been absent from 2 successive Board meetings without adequate reason.

9–208.

(a) In this section, [“nursing home administrator rehabilitation” **“REHABILITATION** committee” means a committee [that:

1 (1) Is defined in subsection (b) of this section; and

2 (2) Performs any of the functions listed in subsection (d) of this section.

3 (b) For purposes of this section, a nursing home administrator rehabilitation
4 committee is a committee] of the Board or a committee of any association representing
5 nursing home administrators **OR ASSISTED LIVING MANAGERS** that:

6 (1) Is recognized by the Board; [and]

7 (2) Includes but is not limited to nursing home administrators **AND**
8 **ASSISTED LIVING MANAGERS; AND**

9 **(3) PERFORMS ANY OF THE FUNCTIONS LISTED IN SUBSECTION (C)**
10 **OF THIS SECTION.**

11 [(c)] **(B)** [A] **THE** rehabilitation committee [of the Board or recognized by the
12 Board] may function:

13 (1) Solely for the Board; or

14 (2) Jointly with a rehabilitation committee representing another board or
15 boards.

16 [(d)] **(C)** For purposes of this section, [a nursing home administrator] **THE**
17 rehabilitation committee evaluates and provides assistance to any nursing home
18 administrator **OR ASSISTED LIVING MANAGER**, and any other individual regulated by the
19 Board, in need of treatment and rehabilitation for alcoholism, drug abuse, chemical
20 dependency, or other physical, emotional, or mental condition.

21 [(e)] **(D)** (1) Except as otherwise provided in this subsection, the proceedings,
22 records, and files of the [nursing home administrator] rehabilitation committee are not
23 discoverable and are not admissible in evidence in any civil action arising out of matters
24 that are being or have been reviewed and evaluated by the [nursing home administrator]
25 rehabilitation committee.

26 (2) Paragraph (1) of this subsection does not apply to any record or
27 document that is considered by the [nursing home administrator] rehabilitation committee
28 and that otherwise would be subject to discovery or introduction into evidence in a civil
29 action.

30 (3) For purposes of this subsection, civil action does not include a
31 proceeding before the Board or judicial review of a proceeding before the Board.

32 [(f)] **(E)** A person who acts in good faith and within the scope of jurisdiction of

[a nursing home administrator] **THE** rehabilitation committee is not civilly liable for any action as a member of the [nursing home administrator] rehabilitation committee or for giving information to, participating in, or contributing to the function of the [nursing home administrator] rehabilitation committee.

THE BOARD IS A MEDICAL REVIEW COMMITTEE UNDER § 1–401 OF THIS ARTICLE.

Subtitle 3. [Licensing] **NURSING HOME ADMINISTRATORS.**

9–315.

(a) Except as otherwise provided in the Administrative Procedure Act, before the Board takes any action under § 9–314 of this subtitle, it shall give the individual against whom the action is contemplated an opportunity for a hearing before the Board.

(b) The Board shall give notice and hold the hearing in accordance with the Administrative Procedure Act.

(c) Over the signature of an officer or the executive director of the Board, the Board may issue subpoenas and administer oaths in connection with any investigation under this title and any hearings or proceedings before it.

(d) If, without lawful excuse, a person disobeys a subpoena from the Board or an order by the Board to take an oath or to testify or answer a question, then, on petition of the Board, a court of competent jurisdiction may punish the person as for contempt of court.

(e) If after due notice the individual against whom the action is contemplated fails or refuses to appear, [nevertheless] the Board may [hear]:

(1) HEAR and determine the matter; OR

(2) ISSUE A DEFAULT ORDER.

SUBTITLE 3A. ASSISTED LIVING MANAGERS.

9–3A–01.

(A) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBTITLE, BEGINNING OCTOBER 1, 2024, AN INDIVIDUAL MUST BE LICENSED BY THE BOARD BEFORE THE INDIVIDUAL MAY PRACTICE AS AN ASSISTED LIVING MANAGER IN THE STATE.

(B) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, IF

1 A LICENSED ASSISTED LIVING MANAGER LEAVES OR IS REMOVED FROM A POSITION
2 AS AN ASSISTED LIVING MANAGER BY DEATH OR FOR ANY OTHER UNEXPECTED
3 CAUSE, THE OWNER OF THE ASSISTED LIVING PROGRAM OR OTHER APPROPRIATE
4 ASSISTED LIVING AUTHORITY SHALL IMMEDIATELY:

5 (I) DESIGNATE A LICENSED ASSISTED LIVING MANAGER TO
6 SERVE IN THAT CAPACITY; AND

7 (II) NOTIFY THE BOARD OF THE DESIGNATED LICENSED
8 ASSISTED LIVING MANAGER'S NAME.

9 (2) (I) 1. IN THE EVENT A LICENSED ASSISTED LIVING
10 MANAGER IS NOT AVAILABLE, THE OWNER OR OTHER APPROPRIATE ASSISTED
11 LIVING AUTHORITY SHALL IMMEDIATELY APPOINT A NONLICENSED INDIVIDUAL TO
12 SERVE IN THE CAPACITY OF INTERIM ASSISTED LIVING MANAGER.

13 2. THE APPOINTED NONLICENSED INDIVIDUAL MAY ACT
14 AS THE INTERIM ASSISTED LIVING MANAGER ON FILING AN APPLICATION WITH THE
15 BOARD REQUESTING A PROVISIONAL LICENSE TO PRACTICE AS THE INTERIM
16 ASSISTED LIVING MANAGER FOR A PERIOD NOT TO EXCEED 90 DAYS.

17 (II) 1. THE OWNER OR OTHER APPROPRIATE ASSISTED
18 LIVING AUTHORITY SHALL IMMEDIATELY NOTIFY THE BOARD OF THE
19 APPOINTMENT AND FORWARD THE CREDENTIALS OF THE INDIVIDUAL APPOINTED
20 TO THE BOARD FOR EVALUATION TO ENSURE THAT THE INDIVIDUAL APPOINTED IS
21 EXPERIENCED, TRAINED, AND COMPETENT.

22 2. THE BOARD MAY ISSUE A PROVISIONAL LICENSE TO
23 THE APPLICANT IF THE BOARD DETERMINES, IN ITS DISCRETION, THAT THE
24 APPLICANT IS OF GOOD MORAL CHARACTER AND CAPABLE OF ADEQUATELY
25 ADMINISTERING THE ASSISTED LIVING PROGRAM FOR THE PROVISIONAL PERIOD.

26 3. THE BOARD, IN ITS DISCRETION, MAY ISSUE A
27 PROVISIONAL LICENSE FOR A PERIOD OF LESS THAN 90 DAYS.

28 4. IF THE BOARD DENIES AN APPLICATION SUBMITTED
29 IN ACCORDANCE WITH SUBPARAGRAPH (I)2 OF THIS PARAGRAPH:

30 A. THE NONLICENSED INDIVIDUAL SHALL IMMEDIATELY
31 CEASE ACTING AS THE INTERIM ASSISTED LIVING MANAGER; AND

32 B. IF A LICENSED ASSISTED LIVING MANAGER REMAINS
33 UNAVAILABLE, THE OWNER OR OTHER APPROPRIATE ASSISTED LIVING AUTHORITY

1 SHALL IMMEDIATELY APPOINT ANOTHER NONLICENSED INDIVIDUAL TO ACT AS THE
2 INTERIM ASSISTED LIVING MANAGER.

3 **5. AN INDIVIDUAL APPOINTED UNDER**
4 **SUBSUBPARAGRAPH 4 OF THIS SUBPARAGRAPH SHALL FILE AN APPLICATION FOR A**
5 **PROVISIONAL LICENSE WITH THE BOARD IN ACCORDANCE WITH THIS PARAGRAPH.**

6 **(III) THE PROVISIONAL PERIOD BEGINS ON THE DATE THAT THE**
7 **LICENSED ASSISTED LIVING MANAGER LEAVES OR IS REMOVED FROM THE POSITION**
8 **AS AN ASSISTED LIVING MANAGER.**

9 **(IV) THE BOARD, ON REQUEST AND FOR GOOD CAUSE SHOWN,**
10 **MAY EXTEND THE INITIAL PROVISIONAL PERIOD FOR A FURTHER PERIOD OF NOT**
11 **MORE THAN 30 DAYS.**

12 **(3) EXCEPT AS PROVIDED IN PARAGRAPH (6) OF THIS SUBSECTION, A**
13 **LICENSED ASSISTED LIVING MANAGER DESIGNATED UNDER PARAGRAPH (1) OF THIS**
14 **SUBSECTION SHALL SUBMIT TO A CRIMINAL HISTORY RECORDS CHECK IN**
15 **ACCORDANCE WITH § 9-302.1 OF THIS TITLE.**

16 **(4) EXCEPT AS PROVIDED IN PARAGRAPH (6) OF THIS SUBSECTION,**
17 **AN INDIVIDUAL APPOINTED IN ACCORDANCE WITH PARAGRAPH (2) OF THIS**
18 **SUBSECTION SHALL SUBMIT TO A CRIMINAL HISTORY RECORDS CHECK IN**
19 **ACCORDANCE WITH § 9-302.1 OF THIS TITLE.**

20 **(5) THE BOARD MAY DENY APPROVAL OF AN APPOINTMENT UNDER**
21 **PARAGRAPH (1) OR (2) OF THIS SUBSECTION BASED ON THE RESULTS OF A CRIMINAL**
22 **HISTORY RECORDS CHECK REQUIRED UNDER PARAGRAPH (3) OR (4) OF THIS**
23 **SUBSECTION AFTER CONSIDERATION OF THE FACTORS LISTED IN § 9-3A-05(B)(1)**
24 **OF THIS SUBTITLE.**

25 **(6) PARAGRAPHS (3) AND (4) OF THIS SUBSECTION DO NOT APPLY TO**
26 **AN INDIVIDUAL LICENSED BY A HEALTH OCCUPATIONS BOARD WHO PREVIOUSLY**
27 **HAS COMPLETED A CRIMINAL HISTORY RECORDS CHECK REQUIRED FOR**
28 **LICENSURE.**

30 **(A) TO QUALIFY FOR A LICENSE, AN APPLICANT MUST:**

31 **(1) BE AN INDIVIDUAL WHO MEETS THE REQUIREMENTS OF THIS**
32 **SECTION;**

1 **(2) BE OF GOOD MORAL CHARACTER; AND**

2 **(3) BE AT LEAST 21 YEARS OLD.**

3 **(B) THE APPLICANT MUST HAVE:**

4 **(1) (I) A HIGH SCHOOL DIPLOMA;**

5 **(II) A HIGH SCHOOL EQUIVALENCY DIPLOMA; OR**

6 **(III) OTHER APPROPRIATE EDUCATION AS DETERMINED BY THE**
7 **BOARD;**

8 **(2) APPROPRIATE EXPERIENCE AS DETERMINED BY THE BOARD;**

9 **(3) COMPLETED A MANAGER-IN-TRAINING PROGRAM APPROVED BY**
10 **THE BOARD;**

11 **(4) PASSED:**

12 **(I) AN EXAMINATION ON STATE STANDARDS DEVELOPED BY**
13 **THE BOARD; AND**

14 **(II) A NATIONAL EXAMINATION FOR ASSISTED LIVING**
15 **MANAGERS ADMINISTERED BY THE NATIONAL ASSOCIATION OF BOARDS OF LONG**
16 **TERM CARE; AND**

17 **(5) MET ANY ADDITIONAL REQUIREMENTS ESTABLISHED BY THE**
18 **BOARD.**

19 **(C) THE BOARD MAY ESTABLISH DIFFERENT APPLICANT REQUIREMENTS**
20 **FOR ASSISTED LIVING MANAGERS CORRESPONDING TO:**

21 **(1) THE DIFFERENT LEVELS OF ASSISTED LIVING DEFINED BY THE**
22 **DEPARTMENT AS REQUIRED BY § 19-1805(A)(1) OF THE HEALTH – GENERAL**
23 **ARTICLE; OR**

24 **(2) THE NUMBER OF BEDS AN ASSISTED LIVING PROGRAM IS**
25 **LICENSED TO PROVIDE.**

26 **(D) THE BOARD MAY WAIVE THE EXPERIENCE AND TRAINING**
27 **REQUIREMENTS UNDER SUBSECTIONS (B) AND (C) OF THIS SECTION FOR AN**
28 **INDIVIDUAL WHO, BEFORE OCTOBER 1, 2022, MEETS THE REQUIREMENTS OF §**

19-1807 OF THE HEALTH – GENERAL ARTICLE AND ANY RELATED REGULATIONS.

TO APPLY FOR A LICENSE, AN APPLICANT SHALL:

(1) SUBMIT AN APPLICATION TO THE BOARD ON THE FORM THAT THE BOARD REQUIRES;

(2) PAY TO THE BOARD THE APPLICATION FEE SET BY THE BOARD; AND

(3) SUBMIT SATISFACTORY EVIDENCE OF HAVING COMPLETED A STATE AND NATIONAL CRIMINAL HISTORY RECORDS CHECK IN ACCORDANCE WITH § 9-302.1 OF THIS TITLE.

9-3A-04.

(A) THE BOARD SHALL KEEP A FILE OF EACH APPLICATION FOR A LICENSE MADE UNDER THIS SUBTITLE.

(B) THE FILE SHALL CONTAIN:

(1) THE NAME, ADDRESS, AND AGE OF THE APPLICANT;

(2) THE NAME AND ADDRESS OF THE EMPLOYER OR BUSINESS CONNECTION OF THE APPLICANT;

(3) THE DATE OF THE APPLICATION;

(4) COMPLETE AND CURRENT INFORMATION ON THE EDUCATIONAL, TRAINING, AND EXPERIENCE QUALIFICATIONS OF THE APPLICANT;

(5) THE DATE THE BOARD REVIEWED AND ACTED ON THE APPLICATION;

(6) THE ACTION TAKEN BY THE BOARD ON THE APPLICATION;

(7) THE IDENTIFYING NUMBERS OF ANY LICENSE OR RENEWAL LICENSE ISSUED TO THE APPLICANT; AND

(8) ANY OTHER INFORMATION THAT THE BOARD CONSIDERS NECESSARY.

(C) THE APPLICATION FILES SHALL BE OPEN TO PUBLIC INSPECTION.

9-3A-05.

(A) SUBJECT TO SUBSECTION (B) OF THIS SECTION, THE BOARD SHALL ISSUE A LICENSE TO ANY APPLICANT WHO MEETS THE REQUIREMENTS OF THIS SUBTITLE.

(B) (1) ON RECEIPT OF THE CRIMINAL HISTORY RECORD INFORMATION OF AN APPLICANT FOR LICENSURE FORWARDED TO THE BOARD IN ACCORDANCE WITH § 9-302.1 OF THIS TITLE, IN DETERMINING WHETHER TO GRANT A LICENSE, THE BOARD SHALL CONSIDER:

(I) THE AGE AT WHICH THE CRIME WAS COMMITTED;

(II) THE NATURE OF THE CRIME;

(D) AN INDIVIDUAL WHOSE LICENSE HAS BEEN REVOKED OR SURRENDERED UNDER THIS SUBTITLE AND WHO SEEKS REINSTATEMENT SHALL MEET THE CONTINUING EDUCATION REQUIREMENTS ESTABLISHED FOR THE RENEWAL OF LICENSES AS IF THE INDIVIDUAL WERE LICENSED DURING THE PERIOD OF REVOCATION OR SURRENDER.

This title may be cited as the [“Maryland Nursing Home Administrators Licensing Act”] **MARYLAND LONG–TERM CARE ADMINISTRATORS ACT.**
