Mr. Casey introduced the following bill; which was read twice and referred to the Committee on Health, Education, Labor, and Pensions

A BILL

- To establish an Interagency Collaborative and Innovation Pilot Program to Address Hunger and Promote Access to Healthy Food Among Older Adults and Adults with Disabilities.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Tools for Ensuring
 - 5 Access to Meals Act" or the "TEAM Act".

1	SEC. 2. INTERAGENCY COLLABORATIVE AND INNOVATION
2	PILOT PROGRAM.
3	Section 201 of the Older Americans Act of 1965 (42
4	U.S.C. 3011) is amended by adding at the end the fol-
5	lowing:
6	"(h)(1) In this subsection:
7	"(A) The term 'Center' means the Research,
8	Demonstration, and Evaluation Center for the Aging
9	Network described in subsection (g).
10	"(B) The term 'Director' means the Director of
11	the Center.
12	"(2) The Director shall establish, in fiscal year 2024,
13	an Interagency Collaborative and Innovation Pilot Pro-
14	gram to Address Hunger and Promote Access to Healthy
15	Food Among Older Adults and Adults with Disabilities
16	(referred to in this subsection as the 'pilot program').
17	"(3) The Director shall carry out the pilot program
18	through the Center.
19	"(4) The Director shall carry out the pilot program
20	to address hunger among, including promoting access to
21	healthy food for, older individuals and adults with disabil-
22	ities by—
23	"(A) implementing best practices for addressing
24	food insecurity, including by promoting access to
25	healthy, affordable, and local or regional food among
26	older individuals and adults with disabilities;

1	"(B) seeking recommendations from Federal
2	agencies about how to support interagency collabora-
3	tion to address food insecurity;
4	"(C) implementing innovative practices to ad-
5	dress food insecurity; and
6	"(D) evaluating the impact of subparagraphs
7	(A) through (C) on addressing food insecurity.
8	"(5) In carrying out the pilot program, the Director
9	shall provide funding for demonstration projects, evalua-
10	tion, and research related to the activities referred to in
11	paragraph (4).
12	"(6) In addition to any other funds appropriated for
13	the Center, there is authorized to be appropriated for the
14	Center, to carry out this subsection, \$5,000,000 for each
15	of fiscal years 2024 through 2028. Funds appropriated
16	under this paragraph shall remain available until ex-
17	pended.".
