3	(1) \$5 for service of summary ejectment papers.
4 5	(2) [\$40] \$60 for service of a paper not including an execution o attachment.
6 7	(3) { \$40 } \$60 for service including an execution or attachment by taking into custody a person or seizing real or personal property.
8 9	(4) [\$40] \$60 for service of process papers arising out of administrativ agency proceedings where the party requesting the service is a nongovernmental entity.
10 11 12 13	(5) For the sale following the execution or attachment of personal property. Three percent of the first \$5,000; two percent of the second \$5,000; and one percent of any amount in excess of \$10,000. The sheriff shall collect a minimum of \$15 and a maximum of \$500 under the provisions of this paragraph.
14 15 16 17	(6) For the sale following the execution or attachment of real property: On and one—half percent of the first \$5,000; one percent of the second \$5,000; and one—half one percent of any amount in excess of \$10,000. The sheriff shall collect a minimum of \$1.50 and a maximum of \$250 under the provisions of this paragraph.
18	(7) \$60 for service of a paper originating from a foreign court.
19	(G) A SHERIFF SHALL COLLECT \$40 FOR SERVICE OF A PAPER FOR:
20	(1) A BREACH OF LEASE;
21	(2) A TENANT HOLDOVER;
22	(3) A WARRANT OF RESTITUTION;
23	(4) A WRONGFUL ENTRY AND DETAINER; OR
24	(5) AN ORDER OF LEVY IN DISTRESS.
