A BILL

To provide for joint reports by relevant Federal agencies to Congress regarding incidents of terrorism, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Reporting Efficiently
- 5 to Proper Officials in Response to Terrorism Act of 2021"
- 6 or the "REPORT Act".

SEC. 2. DUTY TO REPORT.

- 2 (a) Duty Imposed.—Whenever an incident of ter-
- 3 rorism occurs in the United States, it shall be the duty
- 4 of the Secretary of Homeland Security, in coordination
- 5 with the Attorney General and the Director of the Federal
- 6 Bureau of Investigation, to submit to Congress, not later
- 7 than upon completion of the investigation relating to such
- 8 incident by the primary United States Government agency
- 9 conducting such investigation, an unclassified report
- 10 (which may be accompanied by a classified annex) con-
- 11 cerning such incident.
- 12 (b) Content of Reports.—A report under this sec-
- 13 tion shall contain—
- 14 (1) a statement of the facts of the incident of
- 15 terrorism that is the subject of such report, as
- 16 known at the time of such report; and
- 17 (2) any recommendations for changes in prac-
- tices or law, consistent with the Constitution, with
- 19 particular attention to changes that could help pre-
- vent future incidents of terrorism.
- 21 (c) Definition.—In this section, the term "incident
- 22 of terrorism" means an event declared by the Federal Bu-
- 23 reau of Investigation to be an act of terrorism.
