25	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

That the Laws of Maryland read as follows:

3 (b) (1) The Sheriff of Somerset County shall receive an annual salary of not 4 less than [\$85,000] **\$105,000**.

5 Article 20 – Somerset County

- 7 (a) There are 5 County Commissioners for Somerset County, who hold office for 4 years and until their successors are elected and qualified.
- 9 (b) (1) Except as provided in paragraph (2) of this subsection, each 10 Commissioner shall receive an annual salary of [\$10,000] **\$12,000**.
- 11 (2) The President of the County Commissioners shall receive an annual salary of [\$11,000] **\$13,000**.
- 13 9–104.
- 14 (a) (1) Except as provided in paragraph (2) of this subsection, the members of the County Roads Board shall each receive, in addition to their compensation as County Commissioners, a salary of [\$10,000] **\$12,000** annually as a member of the County Roads Board.
- 18 (2) The President of the County Roads Board shall receive, in addition to compensation received as President of the County Commissioners, an annual salary of [\$11,000] \$13,000.
- 21 SECTION 2. AND BE IT FURTHER ENACTED, That, in accordance with Article 22III, § 35 of the Maryland Constitution, this Act may not be construed to extend or apply to 23the salary or compensation of the Sheriff of Somerset County, the County Commissioners 24of Somerset County, the President of the County Commissioners of Somerset County, a 25member of the County Roads Board of Somerset County, or the President of the County 26Roads Board of Somerset County while serving in a term of office beginning before the 27 effective date of this Act, but the provisions of this Act concerning the salary or 28compensation of the Sheriff of Somerset County, the County Commissioners of Somerset 29 County, the President of the County Commissioners of Somerset County, a member of the 30 County Roads Board of Somerset County, and the President of the County Roads Board of 31 Somerset County shall take effect at the beginning of the next following term of office. This 32 limitation does not apply to an individual appointed or elected after the effective date of 33 this Act to fill out an unexpired term.
- 34 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 35 October 1, 2025.
