- 1 FOR AN ACT ENTITLED, An Act to establish the South Dakota Board of Technical Education
- 2 and to revise certain provisions regarding career and technical education and postsecondary
- 3 technical institutes.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 5 Section 1. That the code be amended by adding a NEW SECTION to read:
- 6 Terms used in this Act, mean:
- 7 (1) "Board," the South Dakota Board of Technical Education;
- 8 (2) "Department," the Department of Education;
- 9 (3) "Executive director," the executive director of the board;
- 10 (4) "Facilities," buildings, rooms, property, and permanent equipment, including
- vehicles, used to provide technical education;

- 1 (5) "LEA," a local education agency limited to public school districts, the legal entities 2 that a school district is authorized to establish or a distinct separate LEA established 3 pursuant to section 35 of this Act;
- 4 (6) "Postsecondary technical institute," a public nonprofit school legally authorized to 5 provide career and technical Associate of Applied Science degrees and certificates 6 or their successor equivalents and that are funded wholly or in part by the state as 7 referenced in section 55 of this Act; and
- 8 (7) "Secretary," the secretary of the Department of Education.

- 9 Section 2. That the code be amended by adding a NEW SECTION to read:
  - There is hereby created the South Dakota Board of Technical Education. The oversight of the postsecondary technical institute system is vested in the board. The board shall consist of nine members. Four members shall be selected by the Governor from persons recommended by each of the technical institutes. Each of the four technical institutes shall submit to the Governor a list of not fewer than four persons, from which the Governor shall select one person. Each list shall be submitted no fewer than thirty days before the appointment is to be made. The Governor may reject the entire list and require a technical institute to submit a new list. The Governor shall appoint the remaining board members to represent different geographic regions of the state and to reflect the industries that rely upon the technical institutes to provide a skilled workforce.
- 19 All members shall be appointed with the advice and consent of the Senate.
- 20 Section 3. That the code be amended by adding a NEW SECTION to read:
- 21 No more than six members of the board may be members of the same political party.
- 22 Section 4. That the code be amended by adding a NEW SECTION to read:
- 23 Each member shall serve a three-year term that expires on the last day of October. No
- 24 member may serve more than two consecutive terms. The initial board members shall be

1 appointed for one, two, and three year staggered terms so the terms of no more than three board

- 2 members expire in any year.
- 3 Section 5. That the code be amended by adding a NEW SECTION to read:
- 4 If a vacancy occurs as provided in § 3-4-1, the Governor shall, by appointment, fill the
- 5 vacancy, and the appointee shall serve for the balance of the unexpired term. Any vacancy shall
- 6 be filled in the same manner the vacating member was selected. This partial term does not count
- as a term for the two-term limit provided in section 4 of this Act. However, if the Senate, at the
- 8 next legislative session, fails to confirm the appointee, the appointee may only serve until the
- 9 last day of March. The Governor shall name a new appointee after that date. The subsequent
- appointee is subject to the same conditions as set forth in this section.
- 11 Section 6. That the code be amended by adding a NEW SECTION to read:
- The board shall elect a president from the board's members. The president's term of office
- is two years. Meetings may be held at the call of the president, the executive director, or by joint
- request of a majority of the members if reasonable notice is given.
- 15 Section 7. That the code be amended by adding a NEW SECTION to read:
- The affirmative vote of a majority of the members of the board is required to take any
- official action. The board shall record minutes. The minutes are open to the public. All meetings
- of the board are subject to the provisions of chapter 1-25.
- 19 Section 8. That the code be amended by adding a NEW SECTION to read:
- Each member of the board shall be paid per diem compensation and allowable expenses for
- 21 the member's service on the board pursuant to § 4-7-10.4.
- Section 9. That the code be amended by adding a NEW SECTION to read:
- No employee of a postsecondary technical institute may be a member of the board.
- Section 10. That the code be amended by adding a NEW SECTION to read:

- The board may select and employ an executive director. The board shall provide overall
- 2 policy guidance to the executive director. The board may delegate to the executive director the
- 3 authority to hire and fire board employees.
- 4 Section 11. That the code be amended by adding a NEW SECTION to read:
- 5 The local governing body of each postsecondary technical institute shall retain all powers
- 6 not expressly given to the board.
- 7 Section 12. That the code be amended by adding a NEW SECTION to read:
- 8 The board shall approve rates of tuition and state fees for the postsecondary technical
- 9 institutes. Tuition and fees may vary by course and institution.
- Section 13. That the code be amended by adding a NEW SECTION to read:
- The board shall review and approve recommendations for annual state funding requests for
- 12 the postsecondary technical institutes and make recommendations to the Governor and the
- 13 Legislature.
- 14 Section 14. That the code be amended by adding a NEW SECTION to read:
- 15 The board shall, with the input of the local governing boards of each of the postsecondary
- technical institutes, provide overall policies, goals, and objectives for the management of the
- postsecondary technical institute system to ensure that the needs of the public, business, and
- industry are met to the highest possible degree and in the most cost-effective and efficient
- 19 manner.
- Section 15. That the code be amended by adding a NEW SECTION to read:
- Except as otherwise provided in § 1-16A-95, the board shall consider and act upon
- 22 postsecondary technical institute requests for new construction or major renovation of facilities
- 23 also subject to the provisions of § 1-16A-95. However, the absence of any such action does not
- prevent the Legislature from approving such plans pursuant to § 1-16A-95.

Section 20. That the code be amended by adding a NEW SECTION to read:

The board may enter into and perform the agreements described in Section 19 of this Act. All bonds, notes or other evidences of indebtedness issued by the South Dakota Health and Educational Facilities Authority to finance facilities for use as postsecondary technical institute facilities and outstanding on the effective date of this Act are unaffected by the transfer of functions from the Board of Education Standards to the board. No contract with respect to the bonds is impaired by this Act.

Section 21. That the code be amended by adding a NEW SECTION to read:

The secretary shall apportion and distribute funds made available for postsecondary technical institutes through a formula approved by the board to the LEAs having jurisdiction over postsecondary technical institutes to assist in maintaining and operating those schools. The

- Any LEA operating a postsecondary technical institute shall keep separate the accounting
- and funds for the operation of the postsecondary technical programs. The LEA shall deposit
- receipts, student fees, and income from state and federal sources, as well as any other receipts
- incidental to the operation of the postsecondary technical institute, in any fund created pursuant
- 15 to this Act.
- Section 24. That the code be amended by adding a NEW SECTION to read:
- Any LEA may enter into a lease-purchase agreement with the health and educational
- 18 facilities authority or the board for capital improvements for the design, acquisition,
- 19 construction, equipping, or improvement of facilities the LEA considers necessary or
- appropriate. In addition, the board may enter into any lease-purchase agreement for the capital
- 21 improvements either with an LEA or the health and educational facilities authority.
- Any lease-purchase agreement shall include any terms the health and educational facilities
- 23 authority considers necessary, including without limitation, terms of default, remedies,
- representations, and covenants of the lessee.

- 5 A lease-purchase agreement authorized pursuant to section 24 of this Act:
- 6 (1) May be for a term of no more than thirty years;
- 7 (2) Shall be approved by the governing body of the LEA;
- 8 (3) May provide for the simultaneous conveyance of existing facilities to be leased back 9 with the improvements and other property being financed;

A contract or other agreement may also provide for the release from pledge and lien of any amounts determined to be unnecessary for payment of amounts

currently owed under any lease-purchase agreement. Any pledge of tuition and other student fees are valid and binding from the time the pledge is made. The amount of tuition and other fees pledged and thereafter received shall immediately be subject to the lien of pledge without any physical delivery thereof or further act. The lien of the pledge is valid and binding against the LEA and any other person having any claim of any kind in tort, contract, or otherwise against the LEA, the board, the authority, the state treasurer, or any other person, irrespective of whether the person has notice of the claim. instrument creating a pledge needs to be recorded.

- There is hereby created within the state treasury a trust fund on behalf of the board known as the postsecondary technical institutes facilities fund. The fund shall consist of any appropriation by the Legislature specifically designated for deposit in the fund and any other moneys designated for deposit in the fund, including any investment earnings. The state treasurer may create subfunds or accounts within the trust fund created in this section as the treasurer considers necessary. Any investment earnings in the fund may be transferred annually by the state treasurer to the tuition subaccount established in section 28 of this Act.
- 17 Section 28. That the code be amended by adding a NEW SECTION to read:
  - There is hereby created within the postsecondary technical institutes facilities fund a tuition subaccount. The board may determine and require that all or any portion of the tuition and other student fees payable to an LEA shall be deposited in the subaccount.
