7 remains after prizes are awarded to be used to support future programming at the
8 senior activity center; and generally relating to gaming in St. Mary's County.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

Article – Criminal Law

13-2101.

(a) In this subtitle the following words have the meanings indicated.

~~(d) (1) “GAMING DEVICE” MEANS:~~

~~(I) A GAMING TABLE AT WHICH A GAME OF CHANCE IS PLAYED
FOR MONEY OR ANY OTHER THING OR CONSIDERATION OF VALUE; OR~~

~~(II) A GAME OR DEVICE AT WHICH MONEY OR ANY OTHER THING
OR CONSIDERATION OF VALUE IS BET, WAGERED, OR GAMBLED.~~

~~(2) “Gaming device” includes a paddle wheel, wheel of fortune, chance book,
bingo, Nevada card, and a stamp machine.~~

~~[(2)] (3) “Gaming device” does not include a slot machine, as defined in §
12-301 of this article.~~

(e) “Gaming event” means a carnival, bazaar, ~~[or] raffle, BINGO GAME, CARD
GAME, OR ANY OTHER EVENT AT WHICH A GAMING DEVICE IS OPERATED.~~

~~A qualified organization may hold a gaming event and may operate a gaming device
if an individual or group of individuals does not:~~

~~(1) benefit financially from the operation of the gaming device; or~~

~~(2) receive from the operation of the gaming device any proceeds for
personal use or benefit.~~

(A) IN THIS SECTION, “SENIOR ACTIVITY CENTER” MEANS A COMMUNITY OR
NEIGHBORHOOD FACILITY IN WHICH A BROAD SPECTRUM OF SERVICES ARE
ORGANIZED AND PROVIDED TO SENIOR CITIZENS AND THEIR SPOUSES, INCLUDING
HEALTH, SOCIAL, NUTRITIONAL, EDUCATIONAL, AND RECREATIONAL SERVICES.

1 **(B) A SENIOR ACTIVITY CENTER MAY CONDUCT A GAMING EVENT, BUNCO**
2 **GAME, OR CARD GAME IN THE CENTER.**

3 **(C) A SENIOR ACTIVITY CENTER MAY NOT:**

4 **(1) AWARD A PRIZE OF MONEY EXCEEDING \$50 TO A WINNER IN EACH**
5 **SESSION; OR**

6 **(2) CHARGE A PARTICIPANT MORE THAN \$25 TO PLAY ONE SESSION.**

7 **(D) ANY MONEY THAT REMAINS AFTER PRIZES ARE AWARDED SHALL BE**
8 **USED TO SUPPORT FUTURE PROGRAMMING AT THE SENIOR ACTIVITY CENTER.**

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
10 1, 2023.
