AN ACT

To amend title 38, United States Code, to extend and modify certain authorities and requirements relating to the Department of Veterans Affairs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Department of Vet-
3 erans Affairs Expiring Authorities Act of 2019”.

4 **SEC. 2. EXTENSION OF AUTHORITY RELATING TO VENDEE**
5 **LOANS.**

6 Section 3733(a)(7) of title 38, United States Code,
7 is amended—

8 (1) in the matter preceding subparagraph (A),
9 by striking “September 30, 2019” and inserting
10 “September 30, 2020”; and

11 (2) in subparagraph (C), by striking “Sep-
12 tember 30, 2019,” and inserting “September 30,
13 2020,”.

14 **SEC. 3. EXTENSION OF AUTHORITY FOR OPERATION OF DE-**
15 **PARTMENT OF VETERANS AFFAIRS RE-**
16 **GIONAL OFFICE IN MANILA, THE REPUBLIC**
17 **OF THE PHILIPPINES.**

18 Section 315(b) of title 38, United States Code, is
19 amended by striking “September 30, 2019” and inserting
20 “September 30, 2020”.

1 **SEC. 4. EXTENSION OF AUTHORITY FOR FINANCIAL ASSIST-**
2 **ANCE FOR SUPPORTIVE SERVICES FOR VERY**
3 **LOW-INCOME VETERAN FAMILIES IN PERMA-**
4 **NENT HOUSING.**

5 Section 2044(e)(1)(G) of title 38, United States
6 Code, is amended by striking “fiscal year 2019” and in-
7 serting “each of fiscal years 2019 through 2021”.

8 **SEC. 5. EXTENSION OF TEMPORARY EXPANSION OF PAY-**
9 **MENTS AND ALLOWANCES FOR BENEFICIARY**
10 **TRAVEL IN CONNECTION WITH VETERANS**
11 **RECEIVING CARE FROM VET CENTERS.**

12 Section 104(a) of the Honoring America’s Veterans
13 and Caring for Camp Lejeune Families Act of 2012 (Pub-
14 lic Law 112–154; 126 Stat. 1169), as most recently
15 amended by section 109 of the Department of Veterans
16 Affairs Expiring Authorities Act of 2018 (Public Law
17 115–251; 132 Stat. 3169), is amended by striking “Sep-
18 tember 30, 2019” and inserting “September 30, 2020”.

19 **SEC. 6. TECHNICAL AMENDMENTS.**

20 Title 38, United States Code, is amended as follows:

21 (1) In section 714(e)(2)(B), by striking “to the
22 refer” and inserting “to refer”.

23 (2) In section 1725A(c), by inserting a comma
24 after “a contract”.

25 (3) In section 3313(g)(3)(B)(ii), by inserting a
26 comma after “for books”.

1 (4) In section 3321(a)(1), by striking “Janu-
2 ary,” and inserting “January”.

3 (5) In section 3683—

4 (A) by striking “(b) (b)” and inserting
5 “(b)”;

6 (B) by striking “(c) (c)” and inserting
7 “(c)”;

8 (C) by striking “(d) (d)” and inserting
9 “(d)”.

10 (6) In section 3699(b), by striking “this para-
11 graph” and inserting “this subsection”.

12 (7) In section 7462(b)(4)(A), by inserting “no-
13 tice” after “written”.

14 (8) In section 7696(c)(1), by striking “).” and
15 inserting a period.

16 (9) In section 8104(a), by striking paragraph
17 (3) and inserting the following new paragraph (3):

18 “(3) For purposes of this subsection:

19 “(A) The term ‘major medical facility
20 project’ means a project for the construction,
21 alteration, or acquisition of a medical facility
22 involving a total expenditure of more than
23 \$20,000,000, but such term does not include an
24 acquisition by exchange, nonrecurring mainte-
25 nance projects of the Department, or the con-

1 struction, alteration, or acquisition of a shared
2 Federal medical facility for which the Depart-
3 ment’s estimated share of the project costs does
4 not exceed \$20,000,000.

5 “(B) The term ‘major medical facility
6 lease’ means a lease for space for use as a new
7 medical facility at an average annual rent of
8 more than \$1,000,000.”.
